Title: 2022 Seal Coat Project, C2005 and C2104 - Notice of Completion

<u>Recommended Action:</u> Authorize the Public Works Director/Town Engineer to file a Notice of Completion with the Nevada County Recorder for the 2022 Seal Coat Project, C2005 and C2104.

<u>Discussion</u>: The Town's contractor, DRYCO Construction, has completed the 2022 Seal Coat Project and the Town Engineer recommends acceptance of the project. The project applied seal coating to the following areas:

- Brockway Road Trail, Truckee River Legacy Trail (and spur trails), Frishman Hollow Trail, Stevens
 Lane Trail, Stockrest Springs Trail, Hope Court Trail, and a portion of Trout Creek Trail, as well
 as the East River Street and Glenshire Drive trailhead parking lots using Measure R Funds.
- Fire House parking lot and a portion of the Truckee Depot parking lot using Parking District Funds.
- Town Hall parking lot, Public Service Center parking lot, and a portion of the Truckee Depot parking lot using Town facilities maintenance funds.

Fiscal Impact: On June 14, 2022, Council authorized a contract award amount of \$130,809.86 and a 10% contingency amount of \$13,081 for a total authorized contract expenditure amount of \$143,890.86 to DRYCO Construction. The construction cost by DRYCO Construction is **\$127,607.37**, which is **\$16,283.49** less than the authorized amount.

The following table contains the adopted budget and project construction costs expended from each funding source:
