RESOLUTION 2026-27

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TRUCKEE ESTABLISHING DELINQUENT RESIDENTIAL SOLID WASTE SERVICES ACCOUNTS AND AUTHORIZING THE NEVADA COUNTY AUDITOR-CONTROLLER TO PLACE DIRECT CHARGES ON THE SECURED TAX ROLL FOR COLLECTION OF DELINQUENT ACCOUNTS IN CSA 7, TAX AREA 03

WHEREAS, Nevada County Local Agency Formation Commission adopted Resolution 92-06 making determinations and approving the Proposed Incorporation of the Town of Truckee and reorganization of County Service Areas (CSA) which required the solid waste services, rights, parcel charges, and duties of CSA 4, 5, 6, 8, 9, 10, 11, 19, and 35 to be transferred and consolidated into CSA 7 and named CSA 7 as the successor Agency for Solid Waste Services for the Town of Truckee; and

WHEREAS, the Town of Truckee is responsible for administration of the Solid Waste Franchise Agreement with Tahoe Truckee Sierra Disposal; and

WHEREAS, California Health and Safety Code §§5470 et seq authorizes the Town, through adoption of an ordinance or resolution approved by two-thirds vote of the members of the legislative body, to prescribe, revise and collect charges for solid waste collection services and to collect such charges on the tax roll; and

WHEREAS, the Town of Truckee and the County of Nevada entered into a Standard Form Tax Collection Services Contract on June 20, 1997, allowing for placement of special taxes, special assessments, or parcel charges on the County secured property tax rolls; and

WHEREAS, as part of the ongoing process for administration of the Solid Waste Franchise Agreement and in accordance with Title VI, Section 6.01.030 of the Town of Truckee Municipal Code it is necessary to hold a public hearing and determine that the delinquent accounts for residential solid waste services as identified by Tahoe Truckee Sierra Disposal Inc. are true and correct; and

WHEREAS, notice of public hearing has been provided, oral and written presentations made and received, and the required public hearing regarding the delinquent accounts for solid waste services has been held; and

WHEREAS, property owners have been provided notice by Tahoe Truckee Sierra Disposal and the Town of Truckee that the accounts listed in " Exhibit A" are delinquent and subject to inclusion in the assessment roll against the property; and

WHEREAS, The Town of Truckee is requesting the Nevada County Auditor-Controller to include the amount for each parcel as identified in "Exhibit A" as a direct charge on the secured tax roll; and

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN

OF TRUCKEE, that the Nevada County Auditor-Controller is authorized to place the amount for delinquent accounts for the properties as identified in "Exhibit A" as a direct charge on the secured tax roll, which shall constitute a lien upon the real property.
