**RESOLUTION 2025-41**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TRUCKEE ESTABLISHING  
RESIDENTIAL AND COMMERCIAL SOLID WASTE RATES AND AUTHORIZING THE  
NEVADA COUNTY AUDITOR-CONTROLLER TO PLACE DIRECT CHARGES ON THE  
SECURED TAX ROLL FOR SOLID WASTE COLLECTION SERVICES IN CSA 7,  
TAX AREA 03**

**WHEREAS**, the Town of Truckee is responsible for administration of the Solid Waste Franchise Agreement with Tahoe Truckee Sierra Disposal; and

**WHEREAS**, California Health and Safety Code §§5470 et seq authorizes the Town, through adoption of an ordinance or resolution approved by two-thirds vote of the members of the legislative body, to prescribe, revise and collect charges for solid waste collection services and to collect such charges on the tax roll; and

**WHEREAS**, the Town of Truckee and the County of Nevada entered into a Standard Form Tax Collection Services Contract on June 20, 1997, allowing for placement of special taxes, special assessments, or parcel charges on the County secured property tax rolls; and

**WHEREAS**, as part of the ongoing process for administration of the Solid Waste Franchise Agreement it is necessary to hold a public hearing and establish rates for residential and commercial solid waste services; and

**WHEREAS**, notice of public hearing has been provided, oral and written presentations made and received, and the required public hearing regarding the cost of providing solid waste services has been held; and

**WHEREAS**, the Town Council approves the rate schedules for residential and commercial solid waste services attached hereto as Exhibit A; and

**WHEREAS**, Nevada County at the request of the Town of Truckee has been collecting residential solid waste parcel charges to fund the provision of solid waste services in the Town of Truckee; and

**WHEREAS**, the Town Council has conducted a public hearing and set the parcel charge for residential solid waste services at \$515.28 per year; and

**WHEREAS**, in the event of a parcel being held by multiple owners each owner shall be billed for and shall pay an equal share of the \$515.28 charge, provided that nothing herein shall prohibit the Town from using such legal or equitable remedies as may be available in the event that one or more owners do not pay; and

**WHEREAS**, The Town of Truckee is requesting the Nevada County Auditor-Controller to collect parcel charges for residential solid waste collection services from approximately 12,900 parcels; and

**WHEREAS**, "Exhibit B" shows a list of all Tax Rate Area (TRA) parcels that will be

levied;

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF TRUCKEE**, that the Nevada County Auditor-Controller is authorized to place a direct charge of \$515.28 per residential parcel for solid waste collection services on the secured tax roll for collection, and in the case of a parcel held by multiple owners the Nevada County Auditor-Controller is requested to place such charge on the secured tax roll and bill each owner for an equal share of such charge.
