#### Workshop provided by Design Workshop

- What were your top three biggest challenges with creating these projects?
  - o Cost
  - o Infrastructure
  - o **Zoning**
  - Items that are attractive or appealing with the examples shown in the presentation:
    - Love the idea of an art space. Truckee is already a California Cultural District. It could look at makers space, culinary arts, a cultural center, etc.
    - Repurposing some buildings would fall into that or compliment that.
    - o "Maintaining the grit and authenticity."
    - I like seeing the prior use and seeing it built into something else.
    - Multifamily housing.
    - Workforce housing.
    - Outdoor space and how it is still open and communal.
    - o Outdoor space that is covered so you can still use it in the winter.
    - Colorful finish work.
    - Essential services could fit in these spaces.
    - Would like to see neighborhood services added in this space (daycare, market, etc.)

### Public Comment

Jack Guzman: Where do customers come from? If I opened a coffee shop tomorrow, I am not going to get new customers, I am taking from another business. We may be saturating the marketplace for the market we have here. Our population here can only support so much. We have tourism, but they also leave.

Laura Sailor: Thanked the town staff and consultants for putting together this presentation and workshop for the committee. Recommended to look to neighbors like Grass Valley's historical

district, a papermill converted in Scotland, Zermat, a town where they do not allow cars, Steamboat Springs, CO for their transportation.

Jake Hudson: The Rock Garden is a good example that mirrors the "Stoneyard" example in the presentation. We tried to make a mural in Truckee, but it wasn't in the right spot because of design standards.
