**ORDINANCE 2023-13**

**AN ORDINANCE AMENDING CHAPTER 10.21 OF THE TRUCKEE MUNICIPAL CODE  
REGARDING ALTERNATIVE TRANSPORTATION DEVICES ON PAVED TRAILS**

**WHEREAS**, there has been increased usage of multi-use trails within Truckee and the emerging technology of clean energy devices has created a need to update the allowed uses and regulations on multi-use trails; and

**WHEREAS**, a 259-response community survey was completed, two stakeholder meetings were held, and a community meeting was conducted to understand the communities desire as to changes in the allowed uses on multi-use trails; and

**WHEREAS**, there have been 22 calls for service related to incidents on multi-use trails and the Town wishes to create a safe environment for all users on multi-use trails; and

**WHEREAS**, based on this feedback, the Town Council desires to implement a 15 mile-per-hour speed limit for all modes of transportation, and a reasonable and prudent speed not to exceed 15 miles-per-hour when passing other users of the multi-use trails;

*The Town Council of the Town of Truckee Does Ordain as Follows:*

**Section 1.** Chapter 10.21 of the Truckee Municipal Code is hereby amended to read as set forth in Attachment A, attached hereto and incorporated herein by reference.

**Section 2.** If any section, subsection, clause, or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of the ordinance. The Town Council of the Town of Truckee hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause, and phrase thereof irrespective of the fact that one or more sections, subsections, sentences, clauses, or phrases may be held invalid or unconstitutional.

**Section 3.** Posting and Publications: The Town Clerk is hereby directed to publish this ordinance in accordance with the law.
