

Grant Program for Single-Use Foodware Reduction

The Town of Truckee is offering one-time grant funding to assist businesses in transitioning to the new Foodware Requirements of the Town's single-use foodware reduction ordinance. The below categories are available to provide up to \$1,500 of funding for eligible businesses. Eligible businesses can apply for funding for both Category A and B; they are not restricted to one category.

Category A: Dishwashing equipment

Eligibility: Prepared food vendors within Town of Truckee limits are eligible. Prepared food vendors include a food service establishment (carry out, quick service, full service), bakery, food products store, drugstore, bar, or other similar establishment selling prepared food (prepared on-site at the vendor) to be consumed on or off its premises.

Eligible use of grant funds: Up to \$1,000 reimbursement for procurement or installation of new or upgraded (e.g. larger capacity) equipment to wash and sanitize reusable foodware. Eligible dishwashing expenses may include the purchase or pre-paid lease of new dishwashing equipment and reimbursement for Nevada County Environmental Health permit fees required for dishwasher installation. Once the grant application is approved, the Town will also provide reimbursement for Town Building Department permit fees for dishwasher installation. This reinbursement is in addition to the \$1,000 grant amount. Note: dishwashing chemicals are eligible under funding Category B.

Category B: Single-use foodware reduction

Eligibility: Prepared food vendors within Town of Truckee limits currently utilizing disposable foodware products for in-house dining are eligible. Prepared food vendors include a food service establishment (carry out, quick service, full service), bakery, food products store, drugstore, bar, or other similar establishment selling prepared food (prepared on-site at the vendor) to be consumed on or off its premises. See reporting requirements below.

Eligible use of grant funds: Up to \$500 reimbursement for:

- 1. Procurement of reusable foodware to replace disposable foodware used for in-house dining (e.g. plates, glassware, cups, trays, baskets, cutlery)
- 2. Procurement of bulk dispensers for condiments, utensils, napkins, or other products to assist with self-serve stations for accessory foodware items
- 3. Dishwashing chemicals

Staff wages are not eligible for grant funding. The list of eligible reimbursable items above is not exhaustive. Contact recycle@townoftruckee.com to confirm if other products are eligible.

Deadlines:

- For Grant applications for funding are due by December 1, 2023 March 1, 2024.
- ➤ Reimbursement forms and documents are due by February 1, 2024 April 1, 2024.

Program Requirements:

- 1. A W-9 form must be returned with the grant application.
- 2. Reporting: Businesses seeking reimbursement for procurement of products under Category B shall submit baseline data of quantity of items purchased on an annual basis for items being

submitted for reimbursement, (e.g. annual quantity of disposable foodware or dishwashing chemicals purchased.) Data will be used to measure the number of disposable foodware products used and cost savings before and after implementation. Technical assistance from Town staff is available.

3. Town funding will be dispersed on a reimbursable basis as a single payment to the business. Once notified of the award amount, businesses must submit a reimbursement form, and itemized receipt of payment or invoice and proof of payment, for each product purchased. Receipts or invoices submitted should only include items being submitted for reimbursement. Reimbursement forms and documentation of all purchases are due by February April 1, 2024. The grant award will be paid when all reporting requirements and reimbursement documents have been received by the Town.
