I am writing to protest the not only the TTBID 10 year tax extension but also to share my views of the excessive costs associated with remaining a STR certificate as a second home owner. There needs to be a subcategory to allow for IRS tax status to exempt 2nd home owners to be able to rent without such excessive costs. What I mean by this is if a property owner has a 2nd home and rents out that home for 14 days or less per year all revenue associated with the rental is tax exempt. That is exactly what I have done with our 2nd home in Tahoe Donner for the pat 15 years. This is really important for me now as I am retired and that income is critical for me to be able to help offset HOA and County of Nevada property taxes so that we can continue to enjoy and afford our 2nd home. The current annual ToT STR fees, fire inspection cost, and TTBID taxes to maintain a STR certificate take away a big chunk of the IRS tax benefit. I use to use VBRO to rent out these 14 days but again their cost got so high that I stopped using them and went with the ToT free listing pogram but have not received a single request for our house even when I was available for most Weekends and ski holiday weeks in 2025 and over Christmas 2024.

I am writing to formally protest the renewal of the Truckee Tourism Business Improvement District (TTBID) tax and its continued imposition on lodging business owners such as myself. While I support thoughtful, sustainable tourism and economic development in Truckee, I have serious concerns about the fairness, transparency, and effectiveness of this assessment.

As the owner of 10036 Summit Drive, I have seen firsthand the disproportionate financial burden this tax places on small lodging operators. The additional levy on our business revenues, particularly in the aftermath of the COVID-19 pandemic and amid rising operational costs, reduces our competitiveness and ability to reinvest in our properties, staff, and guest services.

Moreover, there is insufficient evidence that the funds collected through the TTBID are delivering equitable benefits to all contributing businesses. assessment rate shall not drop below three-quarters of one percent (0.75%) nor exceed two percent (2%) of gross short-term lodging rental revenue. Any increase or decrease requested by VTT's Board shall be included in the Annual Report described in Section V and shall take effect if approved by the Council, in its sole discretion, during the fiscal year annual report review.

Based on the benefit received, assessments will not be collected on: stays of more than thirty (30) consecutive days.

- **Renewal:** TTBID renewal requires submittal of petitions from lodging businesses representing more than 50% of the proposed total annual assessment, followed by a Council hearing and an opportunity for written protest. The assessed lodging businesses will receive notice of the public hearing by mail. If there is a written protest by lodging businesses representing more than 50% of the proposed total annual assessment, the TTBID will not be formed.
- **Collection:** Town will be responsible for collecting the assessment on a quarterly basis (including any delinquencies, penalties and interest) from each lodging business located in the boundaries of the TTBID. The extent and nature of the Town's collection efforts will be determined by the Town in its sole discretion.
- **Duration:** The TTBID will have a ten (10) year life, beginning July 1, 2025 or as soon as possible thereafter, and ending ten (10) years from its start date. Once per year beginning on the anniversary of district formation there is a 30-day period in which owners paying more than fifty percent (50%) of the assessment may protest and initiate a Council hearing on district termination. After ten (10) years, the TTBID may be renewed pursuant to the Property and Business Improvement District Law of 1994, Streets and Highways Code section 36600 et seq. ('94 Law) if business owners support continuing the TTBID programs.
- Management: VTT shall continue to serve as the TTBID's Owners' Association. The Owners' Association is charged with managing funds and implementing programs in accordance with this TTBID and must provide annual reports to the Council.
- **Protest:** Any owner of a lodging business within the proposed TTBID that will be subject to the assessment may protest the renewal of the TTBID. If written protests are received from the owners of lodging businesses in the proposed TTBID who represent fifty percent (50%) or more of the estimated annual assessments to be levied, the TTBID shall not be renewed and the assessment shall not be imposed.

I'm writing to express my opposition to the renewal of the Truckee Tourism Business Improvement District (TTBID). While I understand the goal of supporting tourism, I believe renewing this measure would move us in the wrong direction.

Truckee is already well-known and widely visited. With millions living within a half-day's drive and major resorts investing heavily in promotion, the challenge isn't visibility—it's managing demand. That demand is sharply concentrated around holidays and school breaks, which creates issues like overcrowding, traffic, and strain on local infrastructure. Meanwhile, shoulder seasons often lack demand, and additional advertising won't solve that imbalance.

As a short-term rental (STR) owner in Truckee, I am writing to express my concerns regarding the proposed renewal of the Truckee Tourism Business Improvement District (TTBID).

Based on my experience, the TTBID's marketing and promotional activities have had limited, if any, measurable impact on visitor traffic to my property. Truckee's tourism patterns appear to be driven primarily by seasonal factors—particularly snowfall in the winter and school vacation periods in the summer. Outside of these peak times, we typically see a significant drop in visitors, regardless of marketing efforts.

Given this, I respectfully ask: How have the funds collected by the TTBID demonstrably improved business for STR owners like myself? To date, I have seen little evidence that these activities have generated a meaningful return on investment for the local STR community.

I believe it would be reasonable and valuable to pause the TTBID to allow stakeholders to better assess its true impact. Without the influence of ongoing marketing campaigns, we could more clearly evaluate whether the district's activities are essential to sustaining or growing visitor demand.

For these reasons, I urge you to stop the renewal of the TTBID at this time.

The Town of Truckee is hosting a Public Meeting and Hearing to consider the renewal of the **Truckee Tourism Business Improvement District (TTBID)** for another 10 years. This is the next step of the TTBID renewal process.

You are receiving this email to answer some general questions regarding the TTBID and to make you aware of the upcoming Public Meeting and Public Hearing.

Is This a Tax?

No, the TTBID is **not a tax**. It's a **self-assessment**, which means the lodging businesses (like hotels, inns, and short-term rentals) agreed to charge themselves this fee. The process to renew the TTBID started when most of these businesses signed petitions asking for it to continue.

Why Does It Exist?

The purpose of the TTBID is to bring more visitors to Truckee who will stay overnight.

How Does the Fee Work?

- The fee is **1.25% of the money lodging businesses earn** from short-term stays.
- The rate can go up or down each year, but it has to stay between 0.75% and 2%
- Stays longer than **30 days** are not charged this fee.

How Long Will It Last?

The TTBID would last for **10 years**, starting on **July 1, 2025**. Once a year, lodging businesses can request to end it if they represent more than 50% of the total assessment.

Who Manages It?

An organization called **Visit Truckee-Tahoe (VTT)** is in charge of managing the money and using it for tourism-related activities.

Can Lodging Businesses Oppose It?

Yes. Any lodging business that would be affected by the fee can submit a **written protest** by 5pm May 27th meeting (see below) to <u>Truckee@TownofTruckee.gov</u> or to Office of the Town Clerk Town of Truckee 10183 Truckee Airport Road Truckee, CA 96161. If more than 50% of the total assessments are protested, the TTBID will **not** be renewed.
