## Angus Bean v. Truckee Police Department

RE: Government Tort Claim, Gov. Code §§ 910, et seq. Notice and Claim

To Clerk, Board of Supervisors,

PLEASE TAKE NOTICE that pursuant to Government Code §§ 910 et seq., my client, Angus Bean (hereafter referred to as "Mr. Bean") is submitting this letter and the "Truckee Police Department Civilian Complaint Claim Form" provided by your Town's website. By presenting the enclosed claim form, my Client is giving the Town of Truckee formal notice of their civil claim for damages and provides the Town of Truckee with an opportunity to resolve this dispute prior to the initiation of formal litigation.

As outlined in the attached claim form, Mr. Bean was detained in handcuffs by a Truckee Police Department Officer inside the Safeway Grocery Store located at 11920 Donner Pass Road, Truckee, CA 96161 on March 27, 2024. Mr. Bean claims he was harassed and verbally assaulted by a Safeway Employee. In the middle of the verbal altercation between Mr. Bean and the Safeway employee, Mr. Bean was placed into handcuffs and excessively thrown to the ground by your officer. Mr. Bean claims your officer never identified himself. Mr. Bean was blindsided by your officer. Due to lack of communication and lack of identifying information from your police officer, Mr. Bean believed that he was being attacked and did not know who was attacking him. Mr. Bean was thrown so excessively to the ground he suffered severe injuries during your officer's excessive use of force and requested emergency medical assistance. Mr. Bean states that he eventually was taken to the Tahoe Forest hospital and evaluated. Mr. Bean complained his shoulder and ribs were injured. Mr. Bean was only given a chest x-ray, his shoulder was never evaluated. Mr. Bean states he sat in the ER, handcuffed to a bed, while the police officer spoke for him to medical professionals and interrogated him the entire time. Mr. Bean was released from the hospital with no injuries reported and booked into the County jail. Upon Mr. Bean's release from the County jail he still was feeling pain from the excessive force used by your officer. Mr. Bean

Because of your insured's negligence, Ms. Estrada has suffered multiple injuries in the accident.

Mr. Bean is inclined to pursue this case in civil court; however, is willing to resolve the matter informally and release all pending and future claims against the Town of Truckee and individuals in exchange for One Million Five Hundred Thousand Dollars (\$1,500,000.00).

Please contact my office if you would like to discuss early resolution and settlement of this matter, otherwise I will expect to hear back from the Town of Truckee within the prescribed 45-day time frame. Government Code §§ 912.6.
