RESOLUTION NO. 5341-21

A RESOLUTION DECLARING CERTAIN PRIVATE PROPERTY NECESSARY TO ACQUIRE IN ORDER TO CONSTRUCT THE MARTINAZZI AVENUE AND SAGERT STREET INTERSECTION IMPROVEMENT PROJECT.

WHEREAS, in May 2018, Tualatin voters approved a \$20 million bond measure to support high priority transportation projects.

WHEREAS, the City identified the need to improve the intersection performance and pedestrian safety at Martinazzi Avenue and Sagert Street to include a new traffic signal, high-visibility crosswalks, curb ramps, and sidewalks, and improve access to existing transit stops (hereafter "Project").

WHEREAS, there is certain property located adjacent to the Project more particularly described in Exhibits 1 and 2, and depicted in Exhibit 3, which are incorporated by reference (hereafter "Property").

WHEREAS, acquisition of the Property within the Project boundary is necessary to construct the Project and fulfill the purposes of the bond adopted by Tualatin voters;

WHEREAS, the City has Home Rule authority and power under Oregon law and its Charter to exercise eminent domain;

WHEREAS, the City has the authority and power to exercise eminent domain pursuant to ORS 223.005 through ORS 223.020, and ORS 223.105.

WHEREAS, under ORS 35.215(1), the City of Tualatin meets the definition of "Condemner," with the power of eminent domain;

WHEREAS, under ORS 35.235(1), the Condemner must first declare that the acquisition of property is necessary for the project and the purpose of the acquisition prior to attempting to agree with the owner of the property with respect to compensation and damages, if any; and

WHEREAS, under ORS 35.245(1), if the condemner is unable to agree with or locate the owner of the property under ORS 35.235, then an action to condemn property may be commenced in the circuit court of the county in which the property proposed to be condemned, or the greater portion thereof, is located.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TUALATIN, OREGON, that:

Section 1. Under the City's home rule authority and Charter, ORS 223.005 through ORS 223.020, ORS 223.105, and consistent with the procedures outlined in ORS Chapter 35, it is necessary for the City to acquire permanent road right of way for the Project that is compatible with the greatest public good and the least private injury, for the property described in Exhibit 1 (Right-of-Way Legal Description), and as depicted in Exhibit 3 (Map), both of which are incorporated by reference.

Section 2. Under the City's home rule authority and Charter, ORS 223.005 through ORS 223.020, ORS 223.105, and consistent with the procedures outlined in ORS Chapter 35, it is necessary for the City to acquire temporary construction easement for the Project that is compatible with the greatest public good and the least private injury, as described in Exhibit 2 (Temporary Construction Easement Legal Description), and as depicted in Exhibit 3 (Map), both of which are incorporated by reference.

Section 3. It is necessary to obtain possession of the Property, as described in Sections 2 and 3, as soon as possible to allow construction on the Project to proceed and be completed on schedule within budgetary limitations.

Section 4. If the City is unable to negotiate an agreement for the acquisition of the necessary real property rights, the City Attorney, or designee, is authorized to commence and prosecute in the Circuit Court of Washington County in the name of City of Tualatin, any necessary proceedings for the condemnation and immediate possession of necessary real property rights and for the assessment of damages for the taking of the Property.

Section 5. The City Attorney is fully authorized to make offers, negotiate final settlement, and pay funds to acquire the property through negotiation, settlement, or litigation without returning to Council for additional authority in any amount that does not exceed the City Manager's Public Contracting authority.

Section 6. The City Manager, or designee, is authorized to draw a warrant on the Transportation Project Fund of the City for the acquisition of the property consistent with this resolution, in any amount that does not exceed the City Manager's Public Contracting authority.

Section 6. This resolution is effective upon adoption.
