### **RESOLUTION NO. 3343**

# A RESOLUTION ESTABLISHING RATES FOR TOWING AND STORAGE FOR PRIVATE PROPERTY IMPOUND PURSUANT TO GRESHAM REVISED CODE ARTICLE 9.75 AND REPEALING RESOLUTION NO. 3039

## The City of Gresham finds:

A. GRC 9.75.070 provides that the council shall establish a schedule of approved maximum rates and fees that may be charged for Private Property Impounds.

### THE CITY OF GRESHAM RESOLVES:

## **Section 1.** The following definitions shall apply to this resolution:

<u>Class A Tow.</u> A tow of a passenger vehicle, motorcycle, truck or van up to ¾ ton size, unloaded, or a vehicle not exceeding 10,000 pounds, which requires a Class A tow truck.

<u>Class B Tow.</u> A tow of a vehicle exceeding 10,000 pounds Gross Vehicle Weight (GVW), which requires a Class B tow truck.

<u>Class C Tow.</u> A tow of a vehicle exceeding 20,000 pounds GVW, which requires a Class C tow truck.

### **Section 2**. The maximum rates and fees for GRC Article 9.75 are set as follows:

## **Basic fees for towing may not exceed:**

Release at Scene (RAS)		
A. This fee may only be assessed if:		
1. The PPI Tower has completed the hookup and attachment of all safety equipment, and the tow truck's transmission is engaged, and it has commenced driving forward		
2. If PPI Tower is outside of vehicle when vehicle owner / driver returns, a RAS fee may not be charged.		
B. RAS fees must not exceed:
