# **Special Reports**

1. Tualatin Valley Fire and Rescue District 2023 State of the District

Chief Laura Hitt delivered the Tualatin Valley Fire and Rescue 2023 State of the District address, where she outlined the department's mission to create safer communities through prevention, preparedness, and effective emergency response. She highlighted the department's adoption of a strategic plan to guide their efforts, which includes a focus on recruitment and promotions over the past year.

Chief Hitt provided an update on the department's bond, which will fund the relocation of an existing fire station, improvements to other stations, upgrades to the training center, replacement of response vehicles, and the purchase of land for future stations. She also shared incident response data for 2022, indicating that Tualatin had 3,930 responses. Chief Hitt highlighted the department's use of new technology, including vehicles that supplement support for Washington County's transportation failures. The department has also been holding risk reduction and

education sessions for the public at 588 events. Chief Hitt announced the board of directors will request a levy replacement in May 2024 to fund firefighters, paramedics, support personnel, and equipment.

Councilor Sacco shared her positive experience attending the community academy last year and inquired about the transport issues and the upcoming agreement with AMR, and if it would affect other private parties. Chief Hitt explained each county is responsible for managing a provider for these services.

Council President Pratt mentioned she would be attending the community academy in the upcoming weeks and asked about the difference between an EMT and Paramedic. Chief Hitt clarified that in order to be a firefighter, one must have an EMS license, and there are different levels of that license.

Council President Pratt also asked about how the public could find out more information about CPR. Chief Hitt shared the department has resources available on their website.

Councilor Reyes asked about the time it takes for someone to become a paramedic. Chief Hitt replied becoming a paramedic typically involves a two-year degree program.

2. Engagement Plan to Gather Feedback on Draft Climate Action Plan

Management Analyst Maddie Cheek and Deputy Public Works Director Nic Westendorf presented the Community Engagement Plan for the draft Climate Action Plan (CAP). Analyst Cheek explained they will be meeting with each city department to discuss the proposed actions, relevant impacts, and fine-tune language. She also mentioned the next group they will engage with is the business community to gather feedback, share climate actions, and provide information on the online open house. Analyst Cheek shared the upcoming online open house, which will allow community members to provide feedback on the draft CAP and understand the level of community support. She shared staff will return on July 10<sup>th</sup> to present the draft CAP with potential adoption happening in September.

Council President Pratt inquired about engaging the Business CIO and city advisory committees. Analyst Cheek responded they can be added to the list.

Councilor Reyes asked how door-to-door outreach will be conducted. Analyst Cheek explained the process.

Mayor Bubenik suggested targeting businesses with large fleets and HVAC systems that affect the environment.

Director Westendorf shared that the city is preparing a grant application for electric vehicle charging stations and will be working with Portland General Electric for the necessary matching funds. Councilor Brooks thanked staff for putting together the grant application.

Councilor Hillier asked if there is a policy component for the grant application. Director Westendorf stated they will be putting together a draft policy to include with the application.

# **General Business**

Consideration of <u>Ordinance No. 1474-23</u> Establishing a Core Area Parking District (CAPD) Tax Rate for Fiscal Year 2023/24 Finance Director Don Hudson stated the ordinance tonight will set the new tax rate for next year. He stated the Core Area Parking District Board met and are recommending a 7% tax increase based on the schedule in the municipal code.

Councilor Reyes spoke on behalf of the board. She stated the decision was not taken lightly. Councilor Reyes expressed gratitude for the business community who serve on the board.
