# **Special Reports**

1. Outside Agency Grant Awardee- Love, Inc.

Love Inc. Executive Director Ken Caron thanked the Council for their continued partnership in supporting community members in need. He stated that the city's grant funding has been instrumental in allowing the organization to keep its doors open. Director Caron also shared several client testimonials illustrating the impact of their services.

# Public Hearings - Legislative or Other

1. Consideration of <u>Resolution No. 5888-25</u> Adopting the City of Tualatin Budget for the Fiscal Year Commencing July 1, 2025, Making Appropriations, Levying Ad-Valorem Taxes, and Categorizing the Levies

Mayor Bubenik opened the hearing in accordance with state law.

Finance Director Don Hudson presented a resolution adopting the City of Tualatin's budget for the fiscal year commencing July 1, 2025, making appropriations, levying ad valorem taxes, and categorizing the levies. He stated the Budget Advisory Committee approved the budget on May 28 and forwarded it to the Council for consideration. Director Hudson stated council may make changes not exceeding 10% of the total budget. He presented two amendments: the first carries over \$6,000 in Library funds for promotional items related to the new mastodon mascot and rebranding that will not be expended by June 30; the second adds \$40,000 to the Parks and Recreation budget to support a new meal program at the Juanita Pohl Center, following Council direction at the June 9 meeting to replace the Meals on Wheels lunch service. Director Hudson stated with these amendments, the total proposed budget for FY 2025–26 is \$165,489,430.

Director Hudson reviewed the Council priorities addressed in the budget. He stated the resolution imposes a general government tax rate of \$2.2665 per \$1,000 of taxable assessed value, along with \$5,263,160 levied for bonded debt.

Finance Director Don Hudson presented an ordinance establishing the core area parking district tax rate for FY 25/26. He stated the Core Area Parking District Board met and determined to maintain the current tax rate for the district.

2. Consideration of <u>Resolution No. 5887-25</u> Amending Water, Sewer, Stormwater, Road, and Parks Utility Fee Rates Inside the City of Tualatin and Rescinding Resolution No. 5785-24

Finance Director Don Hudson presented a resolution amending utility rates for water, sewer, stormwater, and road utility fees. He stated the water, sewer, and stormwater rates are based on recommendations outlined in the City's adopted master plans. The road utility fee is determined using a three-part index that includes the Consumer Price Index, fuel prices, and construction cost index, as detailed in the staff report. Director Hudson noted that the average residential customer will see their monthly utility bill increase by approximately \$7.27.

Councilor Gonzalez asked about the System Development Charges (SDCs) and whether those funds would be used to support the Climate Action Plan. Director Don Hudson clarified that SDCs are designated for infrastructure projects and are not intended to fund the Climate Action Plan.

3. Consideration of **Resolution No. 5893-25** Calling on Clean Water Services to Take Certain Actions

Mayor Bubenik stated that this is the resolution that Council President Pratt requested at the last meeting.

Clean Water Services Chief Utility Relations Officer Joe Gall expressed support for the proposed utility rate recommendations, emphasizing Clean Water Services' commitment as a partner with the City.

Council President Pratt stated that the Council aims to be fiscally responsible, and part of that includes hearing from all city partners when making rate decisions.

Mr. Gall added that Clean Water Services will be hosting upcoming meetings with local jurisdictions to further discuss regional coordination and service planning.

Motion to adopt Resolution No. 5893-25 calling on Clean Water Services to take certain actions made by Council President Pratt, Seconded by Councilor Brooks.
