SUBJECT: Project Review Reimbursable Agreement with WSDOT for the Trosper Road Interchange Project Amendment No. 2

---

1) Recommended Action:

Authorize the Mayor to sign the Project Review Reimbursable Agreement Amendment No. 2 with WSDOT for the Trosper Road Interchange Project.

The Agreement was recommended for approval on the consent calendar at the January 22, 2026 Public Works Committee.

2) Background:

The I-5 / Trosper Road / Capitol Boulevard Reconfiguration Project is intended to address traffic congestion and pedestrian / bike safety and mobility deficiencies along Capitol Boulevard in the vicinity of Trosper Road per the Capitol Boulevard Corridor Plan. The project will include construction of three roundabouts located at the Trosper Road / I-5 Ramp terminals, Trosper Road / Capitol Boulevard intersection, and at the 6<sup>th</sup> Avenue / I-5 northbound on and off ramps. The project will also include construction of the Trosper Road Extension linking Capitol Boulevard to Linda Street and construction of a new 6<sup>th</sup> Avenue roadway connecting Lee Street directly to the I-5 ramp terminal and Trosper Road. The project will upgrade all existing utilities, provide street lighting, and landscaping and irrigation, within the project limits.

The city of Tumwater entered into an agreement with WSDOT to provide design review and construction administration/inspection services for the project in support of work completed by the city within WSDOT right-of-way.

Amendment No. 2 is requesting an additional \$11,250 to allow WSDOT personnel to complete final project close-out work.

The total cost of the Amendment to WSDOT Project Review Reimbursable Agreement (JC Account 1419) will be \$105,000. This includes \$25,000 for the original agreement, \$50,000 per Amendment No. 1, \$18,750 per Section 3.1 of the original Agreement where both parties agreed that the cost of the work may exceed by up to 25 percent without a written amendment, and \$11,250 per Amendment No. 2.
