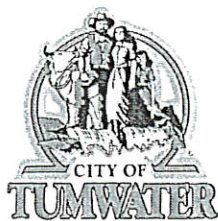

After reviewing your request, the City of Tumwater Community Development Department has concluded that the request qualifies under the exemption set forth in Tumwater Municipal Code (TMC) 16.08.080.G.

Please be advised that the Code prohibits the removal of more than six trees from any parcel of land within three consecutive years, unless a Land Clearing Permit is obtained. Also, this waiver does not authorize the removal of heritage or historic trees, trees located in a green-belt or GreenBelt (GB) zone, trees located in wetlands or critical areas and their buffers, or tree-topping.


