# THIRD AMENDMENT TO SERVICE PROVIDER AGREEMENT FOR TOWING CONTRACT

This Third Amendment ("Amendment") is dated effective this 1<sup>st</sup> day of January, 2023, and is entered into by and between the CITY OF TUMWATER, a Washington municipal corporation ("CITY"), and Summit Towing, a Washington State corporation ("SERVICE PROVIDER").

A. The CITY and the SERVICE PROVIDER entered into a Service Provider Agreement dated effective January 1, 2016, and a First Amendment dated January 1, 2019 and a Second Amendment dated January 1, 2022 whereby the SERVICE PROVIDER agreed to provide towing and storage services ("Agreement").

B. Section 14 of the Agreement provided that the Agreement may only be amended by written agreement signed by the parties.

C. The CITY and the SERVICE PROVIDER desire to amend the Agreement to continue the services described in Section 1 of the Agreement, extend the term of the Agreement, and increase the rates paid to the SERVICE PROVIDER.

NOW, THEREFORE, the parties agree to the following terms and conditions:

In consideration of the SERVICE PROVIDER continuing to provide the services described in Section 1 of the Agreement, Section 4.C of the Agreement shall be amended to increase the compensation paid to the SERVICE PROVIDER pursuant to the accepted bid proposal attached hereto as Exhibit "B-3" and by this reference incorporated herein. The total amount of the agreement and this Third amendment shall not exceed \$35,000.

## 3. FULL FORCE AND EFFECT.

All other terms and conditions of the Agreement not modified by this Amendment shall remain in full force and effect. DATED the effective date set forth above.
