# FIRST AMENDMENT TO SERVICE PROVIDER AGREEMENT FOR TOWING CONTRACT

This First Amendment ("Amendment") is dated effective this 1st day of January, 2019, and is entered into by and between the CITY OF TUMWATER, a Washington municipal corporation ("CITY"), and Summit Towing, a Washington State Corporation ("SERVICE PROVIDER").

- A. The CITY and the SERVICE PROVIDER entered into a Service Provider Agreement dated January 1, 2016, whereby the SERVICE PROVIDER agreed to provide towing and storage of vehicle services ("Agreement").
- B. Section 14 of the Agreement provided that the Agreement may only be amended by written agreement signed by the parties.
- C. The CITY and the SERVICE PROVIDER desire to amend the Agreement to continue the services described in Section 1 of the Agreement by extending the term of the Agreement, and increasing the compensation paid to the SERVICE PROVIDER.

NOW, THEREFORE, the parties agree to the following terms and conditions:

### 1. TERM.

Section 2 of the Agreement shall be amended to extend the term of the Agreement until December 31, 2021.

### 2. COMPENSATION.

In consideration of the SERVICE PROVIDER continuing to provide the services described in Section 1 of the Agreement, Section 4.C. shall be amended to increase the compensation paid to the SERVICE PROVIDER pursuant to the accepted bid proposal attached hereto as Exhibit "B-1" and by this reference incorporated herein. The total amount of the agreement and this first amendment shall not exceed \$30,000.

### 3. FULL FORCE AND EFFECT.

All other terms and conditions of the Agreement not modified by this Amendment shall remain in full force and effect.
