### ORDINANCE NO. O2023-001

**AN ORDINANCE** of the City Council of the City of Tumwater, Washington, amending and replacing, Chapter 9.04, Adoption of Specific RCW Sections, of the criminal code for the City of Tumwater as more particularly set forth herein.

**WHEREAS**, the City's criminal code has not been comprehensively updated since 2010; and

WHEREAS, many cities find that adopting the state criminal code as the city's criminal code allows for changes in state law to be automatically incorporated; and

WHEREAS, adoption of state law by reference allows a police officer to use the state code number which provides clarity and consistency between jurisdictions for defendant, prosecutors and court; and

**WHEREAS**, some sections of the state criminal code have been amended or repealed since the adoption of the City's criminal code in 2010; and

**WHEREAS**, the City Council finds that amending the City's criminal code is in the best interests of the City and supports the health, safety and welfare of the citizens of Tumwater.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF TUMWATER, STATE OF WASHINGTON, DOES ORDAIN AS FOLLOWS:
