Here is some more information.

The tree is in the Glenwood Park neighborhood park, at the very end of Glenwood Drive, near the shore of Trosper Lake. We weren't officially Tumwater until about a week ago!

I would love status for the tree if it is indeed an old tree, to protect it from people who may want to clear the little park in the future.

I think the neighborhood may be in what was either the Ferguson or Rutledge homestead, as it is behind the monument where the blockhouse was built. The park has a variety of trees in a little wooded area.

Preliminary measurements of the tree's circumference about 5 feet above the ground yielded an estimated age of 400 - 500 years old, but I know it isn't that simple. I had a few emails back and forth with a knowledgeable person on the Evergreen faculty, who suggested looking at bark characteristics and branching patterns, both of which seem right for a very old tree.

The dog in the photos is about 50 lbs. It, of course, looks much larger in person.
