## MUNICIPAL MINUTES CITY OF TUPELO STATE OF MISSISSIPPI SEPTEMBER 16, 2025

The Tupelo City Council held its regular meeting in the Council Chambers in the City Hall building on Tuesday, September 16, 2025, at 6:00 p.m. The following Council Members attended: Chad Mims, Lynn Bryan, Travis Beard, Nettie Davis, Janet Gaston, and Rosie Jones; Ben Logan, City Attorney and Sandra Shumaker, Clerk of the Council. Council Member Bentley Nolan was absent. Council Member Nettie Davis asked Reverand Fitzpatrick to the invocation and James Paul Perry with Boy Scout Troop #12 led the pledge of allegiance. Council President Janet Gaston called the meeting to order at 6:00 p.m.
