SUMMARY NOTICE BY PUBLICATION

ORDINANCE AMENDING DEVELOPMENT CODE CHAPTER 2 - DEFINITIONS BY ADDING "ALCOHOLIC BEVERAGES" AND "PACKAGE RETAILER PERMITTEE" AND CHAPTER 11 BY CREATING 11.10 -LOCAL ZONING REGULATIONS ON ALCOHOLIC BEVERAGES AS DEFINED BY MISS. CODE ANN. SECTION 67-1-5.

(TA25-02.02)

Pursuant to the Miss. Code Anno. §21-17-9, in lieu of the full text being printed, the following explanatory statement summarizes the substance of the ordinance. A copy of the full text of the ordinance has been posted (a) on the first floor of City Hall at 71 East Troy Street, Tupelo, Mississippi 38804, (b) the first floor of the Lee County Justice Center at 200 West Jefferson Street, Tupelo, MS 38804, (d) Lee County Library at 219 N. Madison Street, Tupelo, MS 38804. Any resident may request a copy of the full text of the ordinance from City Clerk Kim Hanna on the 2nd floor of City Hall at 71 East Troy St., Tupelo, MS 38804.

SUMMARY

This ordinance amends City of Tupelo Development Code Chapter 2 – Definitions and Chapter 11 – Additional Standards.

The ordinance defines "Alcoholic Beverage" and "Package Retailer Permittee:"

"ALCOHOLIC BEVERAGE" means any alcoholic liquid, including distilled spirits, as defined by Miss. Code Ann. Section 67-1-5, of more than 6% alcohol by weight, and native wines and wine, as defined by Miss. Code Ann. Section 67-1-5, of more than 5% alcohol by weight, capable of being consumed by a human being. The term does not include light wines, light spirit products, and beer, as defined by Miss. Code Ann. Section 67-3-3. "Alcoholic beverage" means any alcoholic liquid, including distilled spirits, as defined by Miss. Code Ann. Section 67-1-5, of more than 6% alcohol by weight, and native wines and wine, as defined by Miss. Code Ann. Section 67-1-5, of more than 5% alcohol by weight, capable of being consumed by a human being. The term does not include light wines, light spirit products, and beer, as defined by Miss. Code Ann. Section 67-3-3.

"PACKAGE RETAILER PERMITTEE" means any person issued a permit authorizing such person to operate a store exclusively for the retail sale of sealed and unopened alcoholic beverages pursuant to Miss. Code Ann. Section 67-1-51(1)(b).

The ordinance provides the following additional standards:

11.10 Local Zoning Regulations on alcoholic beverages as defined by Miss. Code Ann.

Section 67-1-5.

11.10.1 Alcoholic Beverages Package Retailers- The minimum distance between any alcohol beverage package retailer another alcohol beverage package retailer shall be One Thousand Five Hundred (1,500) feet. This distance shall be measured from the nearest point of the floor planned area of the prospective premises to the nearest point of the floor planned area of the existing alcohol beverage package retailer. This distance shall be measured in a straight line, such as air line distance, rather than the usual route of pedestrian travel.

11.10.2 An alcoholic beverages package retailer shall be located on an arterial road as defined in Development Code 6.8.4.1.

The effective date of this Ordinance shall be November 7, 2025.
