A RESOLUTION DECLARING REAL PROPERTY AS SURPLUS PROPERTY LOCATED AT 357/371 MALONE BOULEVARD AND AUTHORIZING THE SALE OF SAID PROPERTY FOR THE PURPOSE OF REVITALIZATION

WHEREAS, the governing authorities of the City of Tupelo, Mississippi are empowered to act with respect to the care, management and control of municipal affairs and its properties for which no provision has been made by general law and which is not inconsistent with existing law pursuant to Section 21-17-1, et seq. of the Mississippi Code Annotated (1972), as amended, including the authority to sell, convey or lease real property on such terms as it may elect that are consistent with statutory authority and

WHEREAS, the subject real properties located 802 Malone Boulevard in Tupelo, Mississippi, is no longer needed for governmental or related purposes, and should be declared surplus; and

WHEREAS, the City of Tupelo, Mississippi has determined that it would be in the best interest of the city to sell the property to Mitchell McCamey for the purpose of revitalization and improvement of the property; and

WHEREAS, the City of Tupelo, Mississippi has obtained an appraisal of the property from Deaton Appraisal Company indicating the value of the property to be Seven Thousand Five Hundred Dollars (\$7500.00). Mitchell McCamey has obtained an appraisal of the property from Rogers Appraisal Company indicating the value of the property to be Five Thousand Five Hundred Dollars (\$5500.00). The sale will be made for Six Thousand Dollars (\$6,000.00), the average of the two appraisals.

NOW THEREFORE, it is hereby resolved and ordered by the City Council of the City of Tupelo as follows:

- 1. The prefatory paragraphs of this Resolution are hereby found and determined to be in accordance with the necessary and warranted exercise of authority of the City of Tupelo.
- 2. The real property located at 802 Malone Boulevard is not needed for governmental or related purposes of the municipality and is hereby found to be declared surplus.
- 3. The sale of said property to Mitchell McCamey for the purpose of revitalization and improvement of said real property is deemed to be in the best interest of the city.
- 4. The Mayor and City Clerk are hereby authorized to execute the sale contract and execute any other documents necessary to sell this property to Mitchell McCamey in the amount of Six Thousand Dollars (\$6,000.00). The contract of sale and deed will be ratified subsequent to closing.
