Dear Mr. Bonds:

I am pleased to submit to you, along with the Mayor and City Council, our conclusions and recommendations regarding the award of the construction contract for the referenced project. Bids were opened at Tupelo City Hall on Tuesday, June 2, 2020 at 10:00 AM local time.

The bids were related to the widening of Coley Road adjacent to Tupelo High School such that an additional merge lane could be implemented from Golden Wave Drive onto Coley Road. This proposed intersection improvement should make this intersection safer for vehicular traffic merging into oncoming traffic along Coley Road. The project includes proposed widening, shoulder improvements, asphalt pavement overlay and striping improvements.

As represented on the attached tabulation of bids, two bids were received for this project from APAC-Mississippi and Gregory Companies, D.B.A. Murphree Paving. The bids ranged from \$153,481.25 - \$171,575.00 based on the estimated quantities included in the bid form. The low bid was from Murphree Paving and provided unit prices for the bid items that were included appropriately on the bid form for a total bid amount of \$153,481.25. The bid was reviewed based on the bidding criteria established for the Project and it appears that Murphree Paving included the proper proposal documentation as required by the Contract Documents.

Thus, it is our recommendation that the City award this contract to Gregory Companies, D.B.A. Murphree Paving for the referenced project.
