The Tupelo City Council held its regular meeting in the Council Chambers in the City Hall building on Tuesday, November 4, 2025, at 6:00 p.m. The following Council Members attended: Lynn Bryan, Travis Beard, Nettie Davis, Bentley Nolan, Janet Gaston, and Rosie Jones; Ben Logan, City Attorney and Sandra Shumaker, Clerk of the Council. Council Member Chad Mims was absent. Council President Janet Gaston gave the invocation and Council Member Bentley Nolan called on Boy Scout Nate Georges to lead the pledge of allegiance. Council President Janet Gaston called the meeting to order at 6:00 p.m.

Water & Light Director Johnny Timmons stated that this increase of \$47,797 was due to the purchase of a 60" sewer plug for the line and concrete pad work at dumpster sites. This brings the total contract price to \$11,950.912 with a revised completion date of January 3, 2026. Council Member Davis moved,

IN THE MATTER OF APPROVAL OF A SOLE SOURCE PURCHASE FROM DEXTER FORTSON ASSOCIATES, INC.

Water & Light Director Johnny Timmons stated that this purchase was for an upgrade in the SCADA telemetry system on the water pumping station that was installed in 2010 and has been maintained by Dexter Fortson Associates, Inc. at the Hive Business Park. Director of Development Services Tanner Newman stated that this was the third payment dedicated to neighborhood revitalization bringing the total to \$750,000. At this time, twenty-three homes have been purchased by NDC, and eleven more are expected to be obtained. Council Member Bryan moved, seconded by Council Member Davis, to approve the payment to CDF for revitalization in the Parkhill community. APPENDIX "N"
