A RESOLUTION TO APPOINT ONE OR MORE DEPUTY CITY CLERKS TO ACT FOR AND ON BEHALF OF THE CITY OF TUPELO WITH SUCH POWER AND AUTHORITY AS VESTED IN THE CITY CLERK

WHEREAS, the City of Tupelo is empowered by Section 21-15-23 of the Mississippi Code of 1972 to appoint one or more deputy city clerks; and

WHEREAS, the City Council of the City of Tupelo finds and determines that additional deputy city clerks are necessary for the efficient administration of municipal government; and.

WHEREAS, personnel changes have necessitated the appointment of new or reappointment of current additional city clerks.

NOW THEREFORE BE IT RESOLVED by the Tupelo City Council as follows:

1. Pursuant to state law, the persons listed below are hereby designated as deputy city clerks for the City of Tupelo:

Rosiland Barr Carol Botts Cade Armstrong Rhonda Cole

- 2. The deputy city clerks so appointed above shall have all the power and authority that is vested in the city clerk of the city and likewise shall serve at the will and pleasure of the governing authorities of the City of Tupelo and under the daily direction of the City Clerk. The compensation for the deputy city clerks named above shall be set from time to time as in the case of other municipal employees, but in no event shall their compensation exceed that of the City Clerk. Any of the deputy city clerks listed above may be removed administratively if other duties so require or for any other reason deemed appropriate, by notice to the individual, signed and in writing by the Mayor.
- 3. Each deputy city clerk shall take and sign the oath of the city clerk and shall provide a surety bond of Fifty Thousand Dollars (\$50,000), the cost for which shall be borne by the City of Tupelo.
