The Tupelo City Council held its regular meeting in the Council Chambers in the City Hall building on Tuesday, July 15, 2025, at 6:00 p.m. The following Council Members attended: Lynn Bryan, Travis Beard, Nettie Davis, Bentley Nolan, Janet Gaston, Ben Logan, City Attorney and Sandra Shumaker, Clerk of the Council. Chad Mims and Rosie Jones were absent. Council Member Lynn Bryan requested Kelly Knight to give the invocation and Council Member Nettie Davis led the pledge of allegiance. Council President Janet Gaston called the meeting to order at 6:00 p.m.
