### IN THE MATTER OF BID APPROVAL COMPACT EXCAVATOR AND ALTERNATE BID REJECTION 24FT GOOSENECK TRAILER

Sealed bids were received by the City for Bid 2021-037PW - Compact Excavator and 24 ft Gooseneck Trailer on December 9, 2021. Council Member Davis moved, seconded by Council Member Beard, to find as lowest and best and award to Thompson Machinery the compact excavator bid in the amount of \$127,900.00 and to reject the alternate bid of the 24 ft gooseneck trailer because the delivery date of the trailer was at least 190 days and could be quoted and obtained sooner. Although not the lowest bid, the bid for the compact excavator received by Thompson Machinery was the lowest and best bid as it exceeded the specifications and offered a better warranty included in the price.
