## Approval of Minutes

## Budget Report

Kim Hannah reviewed the Major Thoroughfare Phase VII Budget Report for the month ending February 28, 2025. Beginning Cash Balance was \$7,337,613. Total Revenue from Property Tax was \$2,824,595, Interest Earned was \$22,450. Total Revenue was \$2,847,044. Total Expenditures for January were \$247,036. Payments included \$9,711 for Personnel Cost, \$207,454 for West Jackson (Madison to Front), and \$29,871 for Maintenance Cost. Ending Cash Balance for is \$9,937,622.

## Current Projects

Brent Spears reviewed updates on the current projects

- Jackson Street (Madison to Front)
  - Underground Utility work is ongoing and going well.
  - Plan to have Pre-Construction meeting later this week.
- New Road (Gloster to Northern Loop)
  - Making good progress on the Construction Plans. Headwaters has prepared the USACE application and is just waiting on feedback from the City/MTP Committee before sending it in. The application and report have an estimated mitigation cost of \$122,308.80 for estimated wetland and stream impacts.
- 2025 MTP Road Maintenance List  
Bids for this work will be opened March/ April timeframe.

Coley Road Curb & Gutter (McCullough to Ridgeway Dr.)  
Job will be advertised and bids opened in April.


South Thomas (Cliff Gookin to Mitchell Road)


## Open Discussion
