#### I. **GENERAL**

The City of Tupelo will accept competitive sealed proposals until **10:00 AM, April 6, 2023**, at City Hall, 71 East Troy Street, Tupelo, Mississippi 38804. All proposals must be equal in performance and quality to the specifications.

### II. <u>TECHNICAL SPECIFICATIONS</u>

The City of Tupelo will be accepting proposals for Pre-Stressed Spun Concrete Poles. This is a 12-month supply bid.

- 4. Ground clips to be factory installed every three feet (3') starting three inches (3") from butt of pole.
- 5. Pole top shall be capped, and the pole butt plugged.
