ORDER

AN ORDER DECLARING A 2008 JOHN DEERE RIDING MOWER AS SURPLUS AND AUTHORIZING THE TRADE OF SAID MOWER FOR THE FAIR-MARKET VALUE EQUIVALENT OF A 2023 CRAFTSMAN GAS PRESSURE WASHER

WHEREAS, local governing authorities may sell or dispose of any personal property belonging to the authority when the property has ceased to be used for public purposes or when, in the authority's judgment, a sale thereof would promote the best interest of the governing authority pursuant to Mississippi Code Anno. § 17-25-25 (1) (1972 as amended); and

WHEREAS, the term "personal property," includes, but is not limited to, equipment, vehicles, fixtures, furniture, firearms, and commodities; and

WHEREAS, the above statutory authority allows multiple means of disposal including private sale so long as the personal property does not exceed One Thousand Dollars (\$1,000.00) in value, and the sell receives a unanimous approval of the board; and

WHEREAS, the Tupelo Coliseum Commission ("Commission") is in current possession of a 2008 John Deere riding mower with Asset #2492 and Tag #14178 that was purchased in April of 2008 for One Thousand Seven Hundred and Ninety-nine Dollars (\$1,799.00), but is no longer operable or useful for public or related purposes and has a fair-market value of no more than Four Hundred and Fifty Dollars (\$450); and

WHEREAS, the Commission desires to trade the riding mower for a 2023 Craftsman 3000 psi gas pressure washer, model #CMXGWFN061146, with a retail value of approximately Four Hundred and Fifty Dollars (\$450) that is currently owned by Cecil Arnold; and

WHEREAS, the two items are of equal value and the trade of these items would promote the best interest of the governing authority.

NOW THEREFORE, it is hereby resolved and ordered by the Tupelo Coliseum Commission Board of Commissioners the following:

- 1. The prefatory paragraphs of this Order are hereby adopted, found, and determined to be in accordance with the necessary and warranted exercise of the authority of the Tupelo Coliseum Commission and shall be incorporated herein.
- 2. The 2008 John Deere riding mower with Asset #2492 and Tag #14178 has a fair-market value of no more than Four Hundred and Fifty Dollars (\$450) and is no longer operable or useful for public or related uses.
- 3. The trade with Cecil Arnold for a 2023 Craftsman 3000 psi gas pressure washer, model #CMXGWFN061146, with a retail value of approximately Four Hundred and Fifty Dollars (\$450) is hereby approved.
- 4. The private sale by trade is in the best interest of the Coliseum Commission and the

City of Tupelo.
5. The Executive Director of the Cadence Bank Arena and Conference Center is hereby authorized to facilitate the trade of the two items contemplated herein.
After a full discussion of this matter, Commissioner With Commissioner moved that the foregoing Order be adopted and said motion was seconded by Commissioner and upon the question being put to a vote was approved
unanimously by the Board on this the 20th day of, 2023.
