On Thursday, May 23, 2024 the Saltillo Police Department was contacted by an off duty Tupelo Police Department officer about his car being broken into. Officers responded and made contact with the victim and he stated that when he came out to his vehicle he noticed that his duty belt was sitting in his front seat. He looked and noticed that his service weapon and two extra magazines were missing. The victim stated that the firearm was a Glock 47 with a direct mount Aimpoint Acro P2 and a Streamlight TLR flashlight attached to the weapon (serial number: CBYM944).
