IN THE MATTER OF REVIEW, APPROVE, REJECT THE LEE COUNTY ASSESSMENT ROLL AND SPECIAL ASSESSMENT ROLL FOR THE CITY OF TUPELO

CFO Kim Hanna informed that the assessment rolls were given to us by the Lee County Tax Assessor and actual figures supported the actual estimates of what was expected.

Councilman Palmer moved, seconded by Councilman L Bryan, to approve the Lee County assessment roll and special assessment roll as submitted. Of those present, the vote was unanimous in favor. A copy of the Lee County Assessment Ross and Special Assessment Roll for the City of Tupelo in on file in the City Clerk's office.

IN THE MATTER OF RESOLUTION FOR THE LEVYING OF AD VALOREM TAXES FOR THE CITY OF TUPELO AND THE TUPELO MUNICIPAL SEPARATE SCHOOL DISTRICT FOR THE TAX YEAR 2020 AND THE CURRENT FY 2020-2021

Councilwoman Davis moved, seconded by Councilman Beard, to adopt the resolution for the levying of ad valorem taxes for the City of Tupelo and the Tupelo Municipal Separate School District for the FY 2019-2020. CFO Kim Hanna reported the millage rate was at 64.10 for the school and 32.7 for the City of Tupelo, which is the same as last year. Of those present, the vote was unanimous in favor. **APPENDIX C**

IN THE MATTER OF RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TUPELO, MISSISSIPPI AUTHORIZING AND DIRECTING THERE BE A ONE PERCENT (1%) INCREASE IN THE BENEFITS FOR ALL MEMBERS AND BENEFICIARIES RECEIVING RETIRED RELIEF OR DISABILITY RELIEF BENEFITS FROM THE FIREMAN'S AND POLICEMAN'S DISABILITY AND RELIEF FUNDS

Councilman Palmer moved, seconded by Councilman Jennings, to approve a 1% increase in the benefits for all members and beneficiaries receiving benefits from the retired fireman's and policeman's disability and relief funds. Councilwoman Davis expressed that she would like to see a larger increase in the future. President M Bryan explained that this retirement system predates the PERS system now used by the City of Tupelo. **APPENDIX D**

<u>IN THE MATTER OF BID 2020-024PW APPROVAL – MATERIALS AND DELIVERY -12 MONTH SUPPLY</u>

Councilman Whittington moved, seconded by Councilman Beard, to find that the lowest and best bids for each item were commercially reasonable and to approve the bids as submitted. The bid approval includes alternate bidders in the event the lowest bidder can not supply when needed. The vote was unanimous in favor. IN THE MATTER OF RATIFICATION OF EMERGENCY DECLARATION FOR SEWER REPAIR

Davey Cole, on behalf of TWL Director Johnny Timmons, explained to the Council that on April 21, 2020 it was discovered that a concrete sewer line collapsed under Plant Road. The collapsed sewer line was 16 feet under the pavement and had to be repaired ASAP to renew sewer services. Councilman Whittington moved, seconded by Councilman Beard, to find the procurement of supplies and services as an emergency and to approve the emergency purchase. The vote was unanimous. IN THE MATTER OF APPROVAL OF BID NO. 2020-027WL

Councilwoman Davis moved, seconded by Councilman Beard, to approve Bid # 2020-027WL Sources of Supply for Minor Water/Sewer Construction/Rehab - 12 month supply to the lowest and best bid of Paul Smithey Construction Company. The vote was unanimous in favor. **APPENDIX I**

IN THE MATTER OF FINAL RESOLUTION FOR LEGGETT & PLATT # 0341

Councilman Whittington moved, seconded by Councilman Beard, to approve the Final Resolution of the City of Tupelo, Mississippi, Granting Exemption from Ad Valorem Taxes to Leggett & Platt Components Company #0341, except State and School District ad valorem taxes, for a period of ten (10) years, beginning the 1st day of January 2020 and ending the 31st day of December 2029, with a total true value of \$283,729.00. The City Council had originally approved a resolution granting this exemption, and the Department of Revenue Office, Office of Property Tax, Exemptions, & Public Utilities Bureau, State of Mississippi, has reviewed the same and certifies by letter dated August 25, 2020, that this company is eligible for the ad valorem tax exemption. The vote was unanimous in favor.

IN THE MATTER OF FINAL RESOLUTION FOR LEGGETT & PLATT # 0908

Councilman Palmer moved, seconded by Councilman Jennings, to approve the Final Resolution of the City of Tupelo, Mississippi, Granting Exemption from Ad Valorem Taxes to Leggett & Platt Components Company #0908, except State and School District ad valorem taxes, for a period of ten (10) years, beginning the 1st day of January 2020 and ending the 31st day of December 2029, with a total true value of \$749,182.00. The City Council had originally approved a resolution granting this exemption, and the Department of Revenue Office, Office of Property Tax, Exemptions, & Public Utilities Bureau, State of Mississippi, has reviewed the same and certifies by letter dated August 25, 2020, that this company is eligible for the ad valorem tax exemption. IN THE MATTER OF LOT MOWING
