Bids for the Veteran's Park Restroom Project were opened after 2:00 p.m., Thursday, June 4, 2020. Bids were received from the following three (3) general contractors:

- Worsham Brothers Construction, LLC., of Corinth, Mississippi
- Century Construction Group, Inc., of Tupelo, Mississippi
- C I G Contractors, Inc., of Corinth, Mississippi

Enclosed is the certified bid tabulation form indicating the results of the bid opening as well as the two (2) additive alternates and two (2) unit prices.

The lowest base bid was offered by **Worsham Brothers Construction, LLC.**, and is in the amount of **\$201,700.00**. The base bid plus additive alternates totals **\$236,900.00**.

According to the contract documents, the Owner has 45 days from June 4, 2020 to contract with the successful bidder.

Our understanding is that the bid amounts exceeded the budget for the project, therefore it is my recommendation to reject all bids.
