Total Revenue from Property Tax was \$111,417, Interest Earned was \$30,654. Total Revenue was \$142,072. Total Expenditures for June were \$488,261. Ending Cash Balance for June is \$8,752,883.

- 2025 MTP Road Maintenance List
  - Falcon will start work soon, plan to mobilize and begin Local Street M&O this week.
- Coley Road Curb & Gutter (McCullough to Ridgeway Dr.)  
Contract has been approved and awarded. Will schedule a Preconstruction Meeting and issue Notice to Proceed to Simmons Erosion Control.
- New Road (Gloster to Northern Loop)  
Design is completed. Must get assistance to relocate fiber box for traffic light controls. Waiting on MDOT Permit Approval.
- Jackson Street (Madison to Front)  
Work is ongoing. Roadwork Contractor is progressing rapidly, contract completion date is 11/10/25.

## Open Discussion


