IN THE MATTER OF REQUEST FOR CONTRACT RATIFICATION

Councilman Beard moved, seconded by Councilman Whittington, to ratify the contract with Stephens TPS, Inc.for the Elevated Water Storage Tank Repair and Repaint (Nelle Street), which was awarded at the March 3, 2020 Council meeting. The vote was unanimous in favor. **APPENDIX J**

IN THE MATTER OF TAX ABATEMENT APPLICATION FOR BULLDOG BURGER

Councilman Palmer moved, seconded by Councilman L Bryan, to approve the application of BBC, LLC (Bulldog Burger), located at 301 and 311 South Gloster Street and within an approved business improvement district, for a commercial ad ad valorem tax abatement in the amount of \$2,512,843 for five years. IN THE MATTER OF RESOLUTION RESCINDING INITIAL APPLICATION FOR EXEMPTION OF 2019 AD VALOREM TAXES OF UNITED FURNITURE INDUSTRIES, INC.

City Attorney Ben Logan explained that on June 16, 2020 the City Council granted preliminary approval for the tax exemption request made by United Furniture Industries, Inc. The Lee County Tax Assessor had requested the Board of Supervisors to deny approval of the request due to the exclusion of previously-exempted inventory/raw materials amount dropping the company's additions below the statutory threshold of \$500,000. Therefore, the City of Tupelo City Council must rescind the approval of the resolution granting exemption from ad valorem taxes.Councilman L Bryan moved, seconded by Councilman Palmer, to rescind the resolution dated June 16, 2020. the vote was unanimous in favor. <u>APPENDIX N</u>

IN THE MATTER OF REVIEW OF CITY-WIDE LEISURE AND RECREATION DISTRICT

Whereas a previous ordinance amendment required review of CITY-WIDE LEISURE AND RECREATION DISTRICT within ninety (90) days, until such time as the Governor removes the State of Emergency or the city council chooses to review earlier, whichever event occurs first. Since 90 days had elapsed without the other conditions triggering review, Councilwoman Davis moved, seconded by Councilman L Bryan, to continue with the Ordinance without any changes. The vote was unanimous in favor.

IN THE MATTER OF AGREEMENT TO PERMIT APPLICATION OF MIDTOWN POINTE AND ACCEPT CITY MAINTENANCE OF CURB CLOSURE OF EXISTING ENTRANCE LOCATED AT NORTHWEST QUADRANT OF THE INTERSECTION OF SOUTH GLOSTER AND VARSITY DRIVE

Councilman Whittington moved, seconded by Councilman Jennings, to approve agreement to a permit application by Midtown Pointe to MDOT and accept city maintenance of a curb closure of an existing entrance located at the NW quadrant of the intersection of S Gloster and Varsity Drive.
