MINUTES OF THE TUPELO TRAFFIC COMMITTEE JULY 21, 2020

A regular meeting of the Tupelo Traffic Committee was held on July 21, 2020, at 1:30 pm in the in the council chambers on the 2nd floor at City Hall. Members present were Mr. Jimmy Avery, Mr. Dennis Bonds, Mr. Norman Cruse, Mr. Jake Logan, Officer Phillip Sanderson and Mrs. Pam Blassingame. Absent were Mr. Barton Wynn, Mr. Emmitt Foster, Mr. Mike Williams, and Ms. Shanta Jones.

Audience members were Mr. Johnny Timmons, Manager TW&L, Mr. Don Lewis, City COO, Mr. Jason Rush, PW, Mr. Mike Bryan, Councilman Ward 6, Mr. Markel Whittington, Councilman Ward 1, Ms. Melissa Nolan and Mr. Charles Richardson (NB # 7), and Ms. Jennifer Mulrooney (NB # 11).

Call to Order

The meeting was called to order by Mr. Dennis Bonds.

A motion was made by Mr. Jimmy Avery to approve the Traffic Committee Minutes of the April 9, 2020 meeting. The motion was seconded by Mr. Norman Cruse and it passed unanimously.

Old Business

1. <u>A request from Mr. Eli Smart, 1771 Morningside Drive, elijahsmart708@gmail.com, to lower the speed limit in the Shady Acres neighborhood.</u>

Mr. Jimmy Avery made a motion to postpone this item until the Policies and Procedures manual for the Traffic Committee is either adopted or rejected by the city council. This motion was seconded by Mr. Dennis Bonds and it passed unanimously.

2. A request from Ms. Lindsey Cochran, Tel. 662-422-9007, for the installation of 40 mph speed limit signs on Heardtown Road.

It was stated that the south side of Heardtown Road is in the city and the north side is in the county. Mr. Dennis Bonds made a motion to postpone this item and allow him to speak with the county supervisor about the current speed limit. Mr. Norman Cruse seconded the motion and it passed unanimously.

3. <u>A request from Ms. Molly Tanner, Tel. 662-231-7043, for the installation of speed tables on S. Church Street.</u>

Mr. Dennis Bonds noted that S. Church Street is defined as a local road and, therefore, does not qualify for a speed table. Mr. Jimmy Avery made a motion to deny this request which was seconded by Officer Sanderson. The motion passed unanimously.

New Business

1. A request from Ms. Shaneka Green, 403 Georgetown Avenue (Hancock Estates), for the installation of "Children at Play" signs on Georgetown Avenue.

Mr. Jimmy Avery made a motion to approve this item. It was seconded by Mr. Norman Cruse and passed unanimously.

2. <u>A request from Ms. Sebreia Hodges, 517 Brown Street, Tel. 662-523-9626, for the installation of "Children at Play" signs on Brown Street.</u>

Mr. Jimmy Avery made a motion to approve this item. Officer Sanderson seconded the motion and it passed unanimously.

3. A request from Mr. Carlton Lewis, 1671 Treeline Drive, Belden, Tel. 662-322-4747, for the installation of "Children at Play" signs on Treeline Drive and Forrest Hill Drive.

A motion to approve this request was made by Mr. Jimmy Avery and seconded by Officer Sanderson. The motion passed unanimously.

4. A request from Mr. Joe Quinn, 2417 Ruth Street, Tel. 501-319-2721, for the installation of "Children at Play" signs on Ruth Street, one on either end and at Foster Street and Ione Street.

Mr. Jimmy Avery made a motion to approve this request. The motion was seconded by Officer Sanderson and passed unanimously.

5. A request from Ms. Marquita Gardner, 1736 Cedarwood, Belden, for the installation of "Children at Play" signs on Cedarwood.

Mr. Jimmy Avery made a motion to approve this item. Officer Sanderson seconded it and the motion passed unanimously.

6. <u>A request from Ms. Sherry Salley, 1408 Reed Street, Tel. 662-321-1530, for the installation of speed tables on Reed Street</u>.

Mr. Dennis Bonds noted that Reed Street is defined as a residential street and could be eligible for a speed table. Mr. Bonds then made a motion to postpone this item and allow the engineering department to assess the street and do a traffic count and report back to the committee at the next meeting. The motion was seconded by Mr. Jake Logan and it passed unanimously.

7. <u>A request from Ms. Melissa Nolan, 1503 Martinhill Drive, Tel. 662-231-9063, tupelomelissa@gmail.com, for the installation of speed tables on Martinhill Drive.</u>

Ms. Nolan and her father, Mr. Charles Richardson were present to discuss this item. They stated that the present posted speed limit is 30 mph. They also noted that there are several residents that ride bikes, walk their dogs, etc.... Mr. Dennis Bonds stated that Martinhill Drive is defined as a local road and does not qualify for a speed table, but there may be other means of traffic calming. Therefore, Mr. Bonds made a motion to postpone this item to allow the engineering department to check into other traffic calming devices. Mr. Jimmy Avery seconded the motion and it passed unanimously.

8. <u>A request from Scott Burns, 912 W. Jackson Street, Tel. 662-401-3349, for the installation of speed tables on W. Jackson Street.</u>

Mr. Jimmy Avery made a motion to deny this request since Jackson Street is classified as a collector road. The motion was seconded by Officer Sanderson and it was unanimously approved.

9. A request from Ms. Madison Gaines, 1301 Kincannon Street, Tel. 662-346-6425, madison@gumtreepm.com, for the installation of "Autistic Child" or Children at Play" signs and speed tables on Kincannon Street.

Kincannon Street is defined as a collector street, so speed tables are not allowed. Mr. Jimmy Avery made a motion to deny the speed tables and approve the "Children At Play" signs. Officer Sanderson seconded the motion and it passed unanimously.

10. A request from Mr. Phil Poe, 237 Doe Run Road, Tel. 662-891-8600, for the installation of speed tables on Doe Run Road and a "Dangerous Curve" sign on Chesterville Road close to Doe Run.

Mr. Jake Logan noted that the "Dangerous Curve" sign is already installed. Doe Run is a local road and not eligible for speed tables. Mr. Dennis Bonds stated that rumble strips could be an option approaching the stop sign in the curve. Mr. Jimmy Avery made a motion to deny the speed tables and allow the engineering and public works departments to look at rumble strips. This motion was seconded by Mr. Norman Cruse and it passed unanimously.

11. A request thru Mr. Markel Whittington, Councilman Ward 1, for help with speeders and golf carts on Purnell Road and traffic control on Walsh Road.

Mr. Markel Whittington and Ms. Jennifer Mulrooney were present to discuss this item. They both stated that speeding is an issue and they are looking for speed control. They also stated that there are lots of children playing and golf carts going frequently from Oak Meadows neighborhood to the country club and back and there is concern for their safety. Officer Sanderson noted that golf carts are illegal on city streets. Mr. Whittington suggested stop signs on Purnell Road at Walsh Road and at St. Andrews/Cedarbrook. Mr. Dennis Bonds made a motion to postpone this item to allow traffic counts to be conducted. Mr. Jake Logan seconded the motion and it passed unanimously.

12. A request from Chief Bart Aguirre, TPD, for the installation of "No Parking" signs on Hilda Avenue.

Officer Sanderson stated that they are having problems with people parking facing the wrong direction on both sides of the street and cars have to weave their way down the street. This is a narrow street which does not allow two cars to pass if someone is parked on the street. Mr. Jimmy Avery made a motion to install "No Parking" signs on the north side of the street. Mr. Norman Cruse seconded the motion and it passed unanimously.

13. A request from Mr. Claude Thomas, 918 Garfield, Tel. 662-871-9350, for the installation of "No Parking" signs on Garfield from Van Buren to President.

Mr. Jake Logan noted that Garfield Street is 28-feet wide which is plenty of room for parking on the street and still allow two cars to pass. A motion to deny this request was made by Mr. Jimmy Avery and seconded by Officer Sanderson. The motion passed unanimously.
