Credit for substitution of wheelchair swings	(-) \$28,511.00
Installation of sub-drainage under playground poured in place surface	(+) \$28,355.00
Summary Change Order Amount (See Attachments)	(-) \$156.00

Justification: Total Deduction (-) \$156.00

After the project was bid, it was determined that sub-drainage is required under the playground poured in-place surface as it is pervious and will not sheet drain to proposed catch basins adjacent to the project site. Sub-drainage will consist of excavation of designated area to prepare for French Drain System. Installation of 4 oz. fabric. Installation of 800 lin. ft. of 4" PVC perforated sewer and drainpipe. Backfill the area with 62 tons of #57 stone. Addition of curb cut for water drainage. Additionally, Bliss Products informed the city that the original ADA swings that were chosen for the project, Liberty Swings, appear to have gone out of business. A replacement option will be a Park Structures Frame and Sports Play wheelchair for credit to the project.
