# MUNICIPAL MINUTES CITY OF TUPELO STATE OF MISSISSIPPI MARCH 4, 2025

The Tupelo City Council held its regular meeting in the Council Chambers in the City Hall building on Tuesday, March 4, 2025, at 6:00 p.m. The following Council Members attended: Lynn Bryan, Travis Beard, Nettie Davis, Buddy Palmer and Rosie Jones; Ben Logan, City Attorney and Missy Shelton, Clerk of the Council. Council Member Chad Mims was absent. Council Member Rosie Jones introduced Tyrone Pegan of New Jerusalem Missionary Baptist Church, who gave the prayer, and Council Member Chad Mims led the pledge of allegiance. Council President Nettie Davis called the meeting to order at 6:00 p.m.

#### CONFIRMATION OR AMENDMENT TO THE AGENDA AND AGENDA ORDER

Council Member Palmer moved, seconded by Council Member Beard, to amend the agenda, as presented. Of those present, the vote was unanimous in favor.

He explained that this improvement meets the criteria for the City's tax abatement program. Council Member Bryan moved, seconded by Council Member Mims, to approve the following resolution: "Resolution Authorizing and Directing the Issuance and Negotiated Sale of Taxable Tax Increment Limited Obligation Bonds, Series 2025 (Tupelo Commons Phase II Project (The Series 2025 Bonds) of the City of Tupelo, Mississippi (The City) in the Principal Amount of Not to Exceed Two Million Three Hundred Fifty Thousand Dollars (\$2,350,000) to Raise Money for the Purpose of Providing Funds for Defraying the Costs of Constructing Various Infrastructure Improvements (as Defined Herein, Funding a Debt Service Reserve Fund, if Applicable, and Paying the Costs of Issuance for the Series 2025 Bonds; and for Related Purposes". Of those present, the vote was unanimous in favor. The Resolution is attached to these minutes as Appendix Q.

Council Member Bryan moved, seconded by Council Member Mims., to take this item off the table and take up in Executive Session. Of those present, the vote was unanimous in favor.
