Chairman Pirkle called meeting to order.

Chairman Pirkle asked the Committee to review and approve the minutes of the April 11, 2022, Major Thoroughfare Program regular meeting. CW Jackson made motion to accept minutes. Ernie Joyner seconded the motion. Minutes were approved unanimously by Committee.

Kim Hanna reviewed the Major Thoroughfare Phase VI Budget Report for the month ending April 30, 2022. Beginning cash balance was \$1,596,240. Total Revenue from Interest Earned was \$79. There were no expenditures for Jackson Street - Clayton to Madison. Ending cash balance for Phase VI Budget was \$1,596,318.

Mrs. Hanna also reviewed the Major Thoroughfare Phase VII Budget Report for the month ending April 30, 2022. Beginning Cash Balance was \$4,396,917. Total Revenue from Property Tax, Homestead Exemption and Interest Earned was \$238,096. Total Expenditures for April were \$20,282 with \$8,321 for Personnel Cost and \$11,961 for Eason Blvd - Veterans to Briar Ridge project. Ending cash balance for Phase VII was \$4,614,731.

Dennis Bonds reviewed updates on the current projects.

App. 5' additional Right-of-way on north side of W Jackson St Thomas to Lumpkin is needed.


Committee discussed what project to focus on after Eason.

MDOT NEWS


MDOT Partner Project at McCullough/Hwy 45/Hilda Ave. A brief discussion was held on potential options to redesign the interchange.
