WHEREAS, January 29th, 2006, Brian Kohlmeier was promoted to the rank of Patrol Lieutenant and later in that same year on November 19th promoted to the rank of Patrol Administrative Captain; and

WHEREAS, December 8th, 2013, Brian Kohlmeier was promoted to the rank of Assistant Chief of Police; and

WHEREAS, Brian graduated as a member of the 258th session of the FBI National Academy in Quantico, VA in 2014; and

WHEREAS, February 7th, 2020, Brian Kohlmeier was promoted to the rank of Chief of Police; and

WHEREAS, Brian volunteered a great deal of time to Crime Prevention, was a Detective, an Evidence Technician, a member of the Two Rivers Honor Guard, a valued Field Training Officer and mentor, an Acting City Manager, and took great pride and dedication in being an innovative leader and advancing technology for Two Rivers City Hall and the Two Rivers Police Department; and

WHEREAS, Brian represented Two Rivers Police Department admirably both county and state-wide as a member of numerous committees and boards and consistently provided exceptional customer service and professional law enforcement services to the citizens of Two Rivers as evidenced by plenty of thank you cards from different organizations and citizens as well as numerous commendable performance reviews by his supervisors; and
