

## **ELECTIONS:**

The election worker list for the 2024-2025 election cycle is on the 12/18/2023 agenda.

As of 12/14/2023, there are 7 candidates that have taken papers out for Councilmember. A primary election will be needed if 7 candidates file the necessary paperwork.
