



RESOLUTION OF REMEMBRANCE IN HONOR OF SCOTT M. “SCOTTY” PAULOW 1958 – 2023

WHEREAS, Scott M. Paulow, affectionately known as “Scotty” throughout our community, was born in Two Rivers on June 25, 1958, was a lifelong resident of Two Rivers and passed away on September 25, 2023 at the age of 65; and

WHEREAS, Scotty was a familiar face around Two Rivers and a friend to thousands of people in the community; and



WHEREAS, Scotty was the ultimate example of a “Man for all Seasons,” well known as:

- The Two Rivers Raiders’ Number 1 Sports Fan;
- Beloved member of the Seehafer Broadcasting crew for Two Rivers sports broadcasts compiling stats, keeping score and offering commentary;
- Longtime employee at the Lester Public Library;
- Faithful member and server at St. Peter the Fisherman Catholic Church; and

WHEREAS, he got an early start in sports as a manager for the high school football and basketball teams from 1973 to 1977 and after graduation started a new career as a statistician for the football and girls softball teams and a scorer for the girls volleyball teams, a job he continued until his passing; and

WHEREAS, his heartfelt love of Two Rivers High School sports not only earned him the status of Number One fan, but also the respect and affection of the school’s student athletes, coaches and fans, plus the unique distinction of being the only non-athlete or non-coach ever inducted into the Two Rivers High School Sports Hall of Fame; and

WHEREAS, while afflicted with Cerebral Palsy, Scotty traveled throughout the community on his three-wheel bicycle, greeting everyone he knew with an infectious smile and wave; his love, concern and respect for others knew no handicap; and

WHEREAS, Scotty passed away suddenly, at home on Monday, September 23, 2023, and his passing has brought forth an outpouring of sadness and sympathy for the family members and many friends he leaves behind; and

WHEREAS, those of us lucky enough to have known Scotty Paulow--and they number literally in the thousands--are the better for having known him, and our City of Two Rivers is a better place for his many contributions to daily life in this community; and

NOW, THEREFORE, the City Council of the City of Two Rivers does hereby, on behalf of all of those in Two Rivers and beyond whose lives were touched by this loving, genuine man, express our appreciation for Scotty Paulow and his time spent among us; we know that he continues to cheer on his beloved Raider sports teams, now from a heavenly skybox; and

BE IT FUTHER RESOLVED THAT, in tribute to Scotty, we join the in the cheer that he so often led to rally up the team or end a game at Two Rivers High School:

“Give me an R, give me an A, give me an I, give me a D, give me an E, give me an R, give me an S. What’s that spell? RAIDERS! What’s that spell? RAIDERS!
