B. Status Update/Reports

1. Staffing Updates

Chief Meinnert reported on the ongoing recruitment and selection processes: City Planner / Community Development Director – accepting applications; Police Administrative Professional – Evidence Custodian: accepting applications; Accounting Clerk – reviewing applications; City Manager Recruitment – position profile and video have been posted. Application deadline was April 28, 2025. Next meeting Thursday, May 8 at 3:00 PM; Recruitment for Seasonal Positions – Now hiring for many Parks and Recreation seasonal positions; Other – many summer seasonal openings

 Czech Flags Flying in Honor of Liberation Day, May 5, 2025 in Two Rivers' Sister City of Domazlice, Czech Republic

Chief Meinnert reported on May 5 in Two Rivers, the United States and Czech flags fly side by side; it's Liberation Day in Domazlice. Eighty years ago, an advance unit from Gen. Patton's Third Army rolled into the town, the German occupiers fled or were taken as prisoner. Lt. Col. Matt Konop of Two Rivers led that advance party and liberated his ancestral hometown from Nazi occupation. The townspeople proclaimed, "We are liberated by one of our own!"

3. Two Rivers Contingent Visiting Domazlice, CZ to Participate in 80th Liberation Day Ceremonies, Make Special Presentation on May 5.

Chief Meinnert reported Our Two Rivers Sister Cities representatives were honored to ride on Sunday in the Convoy of Liberty in Pilsen, a procession that includes over 400 vintage, WWII era vehicles, plus hundreds of mend and women in uniform and in period civilian dress. The parade started at the outskirts of this major city of the western portion of the Czech Republic, and ended in the heart of the historic downtown, where Two Rivers' own Lt. Col. Matt Konop had announced over loudspeakers in May 1945 that War was over, the Nazis were defeated. 4. Law Enforcement Memorial Week with Local, County, State Ceremonies, May 15, 2025

5. National Travel and Tourism Week, Sunday, May 4 through Saturday, May 10, 2025 - Joe Metzen

Tourism Director Joe Metzen reported National Travel & Tourism Week (NTTW) is an annual celebration of the essential importance of the travel industry organized by U.S. Travel Association. NTTW is happening may 4-10, 2025. The Wisconsin Department of Tourism is recognizing the economic and societal benefits of tourism throughout the week. Tourism in Two Rivers enriches the lives and benefits our local economy.

#### 6. Travel and Tourism Event - Joe Metzen

#### 7. New Two Rivers Logo Wear Available

Mr. Metzen reported new logowear is available for purchase at City Hall and Schroeder's Department Store. Thank you to Erickson Sports & Apparel for creating the logowear.

#### 8. Arbor Day Celebration - Mike Mathis

Parks and Recreation Director Mike Mathis reported the Parks and Recreation Department celebrated Arbor Day on April 26 at the Lester Public Library with a tree-felling demonstration and planting new trees. Attendees also learned about he emerald ash borer and other insects. Thank you to the Lester Public Library for the partnership on this project and pictures.

#### 9. Parks and Recreation, Street Tree Planting Project- Mike Mathis

Mr. Mathis reported Parks & Recreation will plant 28 trees across the city at no additional cost to homeowners, funded by taxpayer-supported environmental fees. These trees will replaces those removed and fill empty terraces – adding shade, reducing runoff, and enhancing neighborhood beauty. An additional 60 street trees will be planted on the south side along Roosevelt and nearby streets, supported by a fund for Lake Michigan grant secured by the Lake Michigan Bird Observatory.

#### 10. Parks and Recreation, Adaptive Paddling Workshop- Mike Mathis

Mr. Mathis reported the adaptive paddling workshop, scheduled for May 29 – June 1, 2025, is a four-day training focused on adaptive paddling equipment and instructional techniques for individuals with physical disabilities. To date, 7 instructor candidates, 3 students, and 2 lead instructors are registered. The workshop has also generated 9 hotel stays.

#### 11. LNRP received a \$5,000 WI DNR Surface Water Education Grant - Mike Mathis Mr. Mathis reported LNRP received a \$5,000 Surface Water Education grant from the WI DNR to revitalize the LNRP partner group Friends of the Twin Rivers (FOTR). The group has been working with the City of Two Rivers to increase the recreational use and watershed ecosystem understanding of these rivers. Provided funds from the grant will support FOTR's mission and programmatic initiatives through the collaboration of a second annual Paddle Palooza event, improving Paddlers Park, and recruiting new membership.

#### 12. State Highway 42/Memorial Drive Project - Matt Heckenlaible

Public Works Director Matt Heckenlaible reported the road is still closed to through traffic but accessible for local traffic. Vinton is continuing with concrete base patch removal and replacement along the entire stretch. Lunda completed the concrete overlay portion of the Washington Street bridge last week. Manholes need to be raised in the Washington Street & 12<sup>th</sup> Street intersection this week in preparation of the asphalt overlay. Once the bridge is reopened, the pedestrian detour will be removed. Northeast Asphalt is planning on starting a thin skim layer the week of May 12<sup>th</sup> and planning that all lanes would have that thin layer by the Memorial Day weekend. The remaining asphalt work will be completed post Memorial Day.

13. Lead Service Laterals Replacement - Andrew Sukowaty

Mr. Heckenlaible reported as of April 30, the following services have been replaced: public

side water services – 146; public side sanitary laterals – 104; private side water services – 44; private side sanitary laterals – 18.
