The therapy dog will be a great addition to our professional team's mission to make a positive impact through our strong partnership with the community we serve.

Daisy joined us in April and has begun her training. Daisy will not only be an agency therapy dog for officers and victims, but one that we hope to have visit community schools, retirement homes, participate in community activities, sit in with people during interviews, help calm people during or after crisis intervention, etc. Daisy will have several department members as her handlers and will be available during all shifts.





Daisy was donated in partnership with the WI Law Enforcement Death Response Team (LEDR) from a woman at Blueberry Cottage Labradoodles who wanted to give back to law enforcement and has donated several other therapy dogs to agencies around the state. As part of the LEDR team, Daisy will also be responding to all law enforcement deaths throughout the state.

## **Promotions**

There has been a lot of movement and changes in the department lately with several promotions happening in April. Andrew Raatz was promoted from the Professional Standards Lieutenant to the rank of Captain; Robert Wandrie promoted from Patrol Sergeant to the rank of Patrol Lieutenant, and Jacob Glaser moved from Patrol Lieutenant to lead investigations as Detective Lieutenant. These changes were formally recognized at the City Council Meeting on Monday, April 17th, 2023.

Andrew Raatz was hired with the Two Rivers Police Department in February of 2006 as a Patrol Officer. Since then, Andrew has served the Two Rivers Police Department as a School Resource Officer, Instructor, Field Training Officer, D.A.R.E Instructor, Manitowoc County SWAT Operator, and has devoted a great deal of time and professionalism as the leader of our Police Cadet Program and our Honor Guard. Andrew Raatz was promoted to Lieutenant in 2014 and to the role of Professional Standards Lieutenant in 2017. Andrew Raatz is also a Wisconsin Law Enforcement Command College Class 3 graduate.





## ***Calls for Service by Day of Week:***




## **CRIME CLEARANCE RATE:**

Each law enforcement agency in the Nation submits monthly reports to the Uniform Crime Reporting (UCR) Program. This program collects and reports crime offense data for the Nation, categorizing crime data as Part I or Part II offenses. Part I offenses include: Murder/Non-Negligent, Forcible Rape, Robbery, Assault(s), Burglary, Larceny/Theft, Motor Vehicle Thefts, and Arson. Part II offenses include all other crime classifications outside those defined as Part I offenses. These monthly reports also afford the Two Rivers Police Department the ability to monitor our crime clearance rate. The crime clearance rate is simply the percentage of offenses reported as compared to how many of those offenses were cleared or resolved. The Two Rivers Police Department is proud to note that our crime clearance rates are generally well above the average for the State of Wisconsin. Because some cases that are reported in one month may be solved or “cleared” the next month or months later, it is difficult to state crime clearance rates as purely a monthly rate. For our purposes, we continue to track our CCR rates across the months and years as well.
