### STAFF REPORT

**AGENDA ITEM:**

Consideration to award the 2025 Pavement Marking project PW-2025-05 to Mid State Construction & Stripeing, Incorporated for \$13,923.

**BACKGROUND:**

The pavement marking maintenance project was included this fiscal year to improve safety of our roads. Locations include Dogwood Trail (Senoia to Windsong SD) and Senoia Road from Town Hall to Palmetto Road intersection. Bids were received and opened on January 9, 2025, at 10 AM and read aloud at the Town Hall. The lowest responsive and responsible bidder was Mid State Construction & Stripeing, Inc. for \$13,923.
