RESOLUTION

The undersigned, _____, State of Georgia, being in lawful session assembled on the day and date hereinafter inscribed, in the regular order of business properly presented, find that:

WHEREAS, Public Law 761, 83rd Congress, authorizes the Social Security Administration, at the request of any State, to enter into an agreement with such State for the purpose of extending the benefits of the Old Age and Survivors Insurance System, established by Title II of the Social Security Act, to employees of such State or any political subdivision thereof, including eligible employees under a public retirement system; and

WHEREAS, we are advised that, pursuant to authority of Act No. 82, 1956 Session of the General Assembly, approved February 13, 1956, the State of Georgia, acting by and through its State Agency, may request said Social Security Administration to enter into an agreement with the State of Georgia for the purpose of extending the benefits provided by said Title II to those employees of its political subdivision; and

WHEREAS, this Board is desirous of securing the benefits accorded by said insurance system for the officers and employees of this instrumentality, (to) ~~(not to)~~ include any employees that are in positions covered by a public retirement system; and, in order to insure the fullest benefits thereon, it is deemed necessary that this county enter into an agreement with said State Agency at the earliest date possible:

THEREFORE, BE IT RESOLVED:

1. That this instrumentality, by and through its lawfully constituted _____ does hereby adopt the terms, conditions, requirements, reservation, benefits, privileges, and other conditions thereunto appertaining, of Title II of the Social Security Act, as amended by Public Law No. 761, 83rd Congress, for and on behalf of all the officers and employees thereof and of its departments and instrumentalities, save and except any of such officers and employees who occupies any position, office or any employment not authorized to be covered by applicable State or Federal laws or regulations;

2. That there shall be withheld from any salary or compensation due any such officer or employee not excepted as aforesaid whose compensation qualifies him or her to participation therein the percentage of salary, wage, or compensation, required to be withheld by said Act, whether such compensation be computed in case, quarters, subsistence, or in kind, and reserved in the treasury for remittance;

3. That there shall be appropriated from _____ funds such amounts at such time as may be required by applicable Federal or State laws or regulations for employers contributions and such funds shall be paid in accordance with regulations;

4. That the rules and regulations of the State Agency for the enforcement of said Act shall be adhered to and that reports relating to personnel, payrolls, and otherwise required shall be promptly paid ;

5. That the _____ is hereby designated the custodian of all sums withheld from the compensation of officers and employees and of the appropriated funds for the tax upon the county, and the _____ is hereby made the withholding and reporting agent and charged with the duty of maintaining personnel records for the purposes of this resolution;

6. That this county, accordingly, by the adoption of this resolution, in full ample manner by its lawfully constituted _____ does hereby authorize said _____ to make and enter into agreement with the State of Georgia, by and through its designated Agency, the Employees' Retirement System of Georgia, in full accord with this resolution and said Social Security Act, as amended, and so afford its benefits to the officers and employees of this instrumentality (to) (not to) include any employees that are in positions covered by a public retirement system, in the manner by said law provided.

Be it further resolved that a copy of this resolution fully executed as in original, duly attested by the County Clerk with the Seal of the County attached, be furnished to the Employees' Retirement System of Georgia to be attached to said contract.
