Public Works Related

- PWD actively worked with S. Patel of Mead and Hunt to get contract issues rectified.
- PWD and TA Snyder met with members of DPW&T- OHM to discuss the addition of bump-outs and striping on Gov. Oden Bowie Dr.
- Foreman Sheckels and I met with Amy G to get an overview of the new invoicing system.
- PWS assisted with SGT. Irby's investigation.
- PWS hosted interns for the majority of a day. They assisted with set-up and testing of movie night equipment.
- Foreman Sheckels and I assisted with set-up for National Night Out.

Maintenance and Beautification

- All PW vehicles were inspected by the health Dept for annual licensure.
- TA Snyder and I met with Cameron Spruill of the PG Arts Council to discuss potential art locations and fence wrapping.
- PWD is coordinating with the new Assoc. Dir of DPW&T- OHM Mr. Boyd on providing a bucket truck to replace Water St Banners.

Street and Sidewalk
