Public Works Related

- Ford F-550 finally received from Chesapeake Ford Trucks. Salt spreader and plow removed. Working on getting it registered with County fleet and Gasboy. Next step is getting the PW logos, vehicle numbers, chevron striping for the rear, MES numbers and county hauler inspection.
- PWD attended OEM Hazard mitigation assistance grant program meeting.
- Final review of Hazcom before distribution to staff. Last item pending is First Aid training.
- PWD and Foreman received PD message board shipment. Unloaded and assembled unit.
- PWD and crewmember Raynor stayed over for threat of severe weather to monitor the Town.
- PWD and Foreman Sheckels attended PGCOCS Lunch and Listen held at the community center pavilion.
- PWD attended two Annexation community meetings.
- Assisted grant writer Augustus with info needed for Sustainable Community grant submission.

Maintenance and Beautification

- PWC cut back rose bushes at TH and identified 8 trees/shrubs for pruning.
- PWC preened and mulched TH flower beds and trees.
- PWC Planted spiral evergreens at TH Driveway entry.
- PWC loaded sandbags for business owner in Old Mill Office Park.
- Bushes trimmed along 725 sidewalk, and low hanging limb cut on Valley In.
- Flooding of PW office area cleaned up. Foreman Sheckels and I discussed retaining wall installation to prevent backflow from French drain that will hopefully mitigate the issue at a low cost.
- Herbicide treatment completed at PW yard.

Street and Sidewalk / Mead & Hunt Update

- Pedestrian crosswalk pedestal concrete set and hardwired, Pedestal poles still not on site. Driveway aprons, curb bump outs, sidewalk extensions complete on Water St.
- Re-patch of Spring Branch Dr. completed.
- Mead and Hunt engineers submitted a revision to the road survey report. Still reviewing all documents and updating them with additional changes to be made.
- Working to re-schedule miss utility for stop signs.
