- **Orange:** 96 cases — Best By **10/5/26**
- **Five Star Punch:** 48 cases — Best By **9/7/26**
- **Watermelon:** 32 cases — Best By **2/9/26**

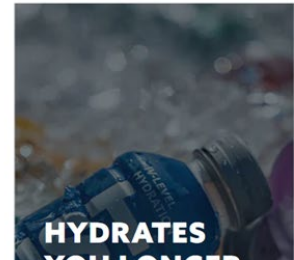
