RENTAL AND SERVICES CONTRACT - TERMS AND CONDITIONS

BOXX will lease the equipment, including one or more modular structures identified on the Cover Page (the "**Structure**"), together with any Carry-On Options and Ancillary Equipment identified on the Cover Page, and all other contents and furnishings (collectively, "**Equipment**") and provide Transportation Services, Installation Services, Dismantle Services or other services, if any, (collectively, the "**Services**"), to Customer for the Minimum Commitment and any Holdover (collectively, the "**Term**") at the Site, in accordance with the attached Terms and Conditions. The Cover Page sets out the meaning for capitalized terms not defined in these Terms and Conditions.

1. **PRICE:** Customer must pay BOXX the Rent, other charges set out in this Contract, and taxes, including without limitation, a personal property fee of eight percent (8%) of the monthly Rent on the Equipment. The Price does not include any amounts for changes in taxes, tariffs, or other similar charges that are enacted after the date of this Contract. BOXX shall be entitled to an equitable adjustment in time and money for any costs that it incurs directly or indirectly that arise out of or relate to changes in taxes, tariffs, or similar charges due to such changes including, without limitation, escalation, delay damages, costs to procure, costs to change suppliers, costs of manufactured equipment or goods, or other costs of any kind resulting from the changes. In the event of such changes, Customer shall execute a change order in an amount commensurate with any actual, direct, and documented increase in material costs incurred as a direct result of such changes. BOXX's fee shall not be increased as a result of such cost increases.

2. **DAMAGE DEPOSIT:** Customer shall pay the amount equal to at least one month's Rent at BOXX's sole discretion (the "**Damage Deposit**"), prior to Delivery of the Equipment, to be held by BOXX without liability to Customer for interest, as security for Customer's performance of the terms and conditions of this Contract, and in furtherance thereof, Customer hereby grants to BOXX a security interest in the cash from time to time comprising the Damage Deposit and all proceeds thereof. In the event of Customer's default, BOXX may apply the Damage Deposit as payment of Customer's lease payment(s), or of Customer's cost, expenses and attorney fees in enforcing the terms of this Contract and to indemnify BOXX, its affiliated entities, and each of their respective directors, officers, employees, agents and contractors (the "**BOXX Parties**") against any damages sustained by the BOXX Parties, provided, however, nothing herein contained shall be construed to mean that the recovery of damages by BOXX shall be limited to the amount of the Damage Deposit. In the event all or any portion of the Damage Deposit is applied as aforesaid, upon demand Customer shall deposit additional amounts with BOXX so that the Damage Deposit shall always be maintained at its original amount. Provided Customer is not in default hereunder, upon the termination of this Contract, any unexpended balance of the Damage Deposit shall be returned to Customer.

3. **PAYMENT:** Unless stated otherwise on the Cover Page, Customer must pay BOXX or its assignee: (i) the first month's Rent, Damage Deposit, taxes, and all other amounts due as specified on the Cover Page upon execution of the Contract; (ii) if the Term begins on the second day through the last day of any month, the Rent shall be prorated for that portion of the month; (iii) all future Rent shall be paid on the first day of each month to BOXX without further notice at its address provided on the Cover Page or such other place as BOXX may from time to time designate in writing; (iv) interest at the rate of 3% per month on overdue amounts until paid; and (v) all costs incurred by BOXX in collecting overdue accounts and repossessing Equipment. The Rent payment will be absolute and unconditional in all events and will not be subject to any offset, defense, counterclaim, or recoupment by the Customer for any reason whatsoever.

4. **EQUIPMENT:**

(a) **Title:** BOXX will remain the owner of Equipment. This Contract is not a financing arrangement, and does not give Customer any ownership, rights in Equipment. BOXX may register a security interest under any applicable laws, and Customer waives any right to receive any related statements or notices from BOXX. Equipment is chattel and is not intended to be or become a fixture. If Site is located on lands not owned by Customer, Customer must obtain a release from the owner of the lands that Equipment will not be deemed a fixture and may be removed without notice at any time. If the Customer, mortgagee or a purchaser of the Customer's property or any creditor of the Customer refuses to admit BOXX's title to the Equipment, refuses to permit BOXX to retake possession of the Equipment or if the Equipment is lost, stolen, damaged or destroyed: (a) the Customer shall forthwith upon demand pay to BOXX the then-current full replacement value of the Equipment, which shall be a debt owed by the Customer to BOXX until paid in full; and (b) this Contract may be terminated immediately by BOXX.

(b) **Care, Custody and Control:** Care, custody and control of Equipment will pass to Customer on "**Delivery**" which is the later of the date on which (i) Equipment is delivered to Site or (ii) the Installation Services, if any, are substantially complete. During the Term, Customer: (i) must retain care,

custody and control of Equipment and keep it on Site; (ii) bears all risk of loss or damage to Equipment; and (iii) must not sub-rent or allow third parties to use Equipment. Customer grants BOXX with permission and a license to enter Site to inspect Equipment and to effect its remedies under Section 10.(a).

(c) **Permits, Costs and Utilities:** Customer must have all necessary licenses and permits, and pay all third-party costs, charges, and taxes for the use of Equipment or related to Services, including tolls, ferry/tunnel charges, permissions and inspections. Customer shall be solely responsible to pay all charges and expenses associated with the installation, connection and use of utilities and the eventual disconnection of same. Any amounts for any such licenses, permits, costs, charges, utilities or taxes paid by BOXX will be invoiced to Customer.

(d) **Alterations:** Customer will not make any alterations, additions, or improvements to the Equipment without BOXX's prior written consent unless such alterations, additions or improvements may be readily removed without damage to the Equipment.

(e) **Location:** The Equipment will not be relocated from its initial location without the prior written consent of BOXX, which will not be unreasonably withheld.

(f) **Maintenance and Care of Equipment:** Unless Customer has agreed to a Maintenance Plan, Customer must maintain Equipment (normal wear excepted) as listed and set-out in Exhibit A attached hereto and must promptly report to BOXX any issues that may arise to the Equipment. Without BOXX's prior written consent, Customer must not add or change any signage to the Equipment. Customer is responsible for any damage resulting from accident, modification, misuse, abuse, neglect, unauthorized repairs/alterations, lack of or improper maintenance, fire, weather or other natural causes (collectively "**Damage**") to Equipment.

(g) **Return of Equipment:** Unless Equipment is purchased by Customer, Customer must clean, winterize and return Equipment at end of the Term in the same condition Equipment was in at Delivery, normal wear excepted. BOXX's costs to do any of the above, to repair any Damage to Equipment, and to return Equipment to the condition it was in at Delivery (normal wear excepted), will be invoiced to Customer.

(h) **Holdover:** If Customer does not provide notice of its intention to extend the term of this Contract at least 60 days prior to the end of the Minimum Commitment, does not enter into a mutually agreed to extension prior to the end of the Minimum Commitment and does not return the Equipment at end of the Minimum Commitment, this Contract will automatically renew for an additional twelve (12) month Minimum Commitment period, and annually thereafter, on the same terms and conditions as set forth herein with the exception that the monthly rental payments for the Equipment will increase by a minimum of ten percent (10%) or as otherwise quoted to the Customer in writing by BOXX at or prior to the end of the initial Minimum Commitment period, or each additional Minimum Commitment period, as applicable ("**Holdover**").

5. **WARRANTY:**

(a) **Warranty:** BOXX provides only the following "**Warranty**":

(b) **Limitations:** Warranty is subject to the following limitations:

- BOXX will, acting reasonably, make all decisions regarding the Warranty, including validity, applicability and appropriate remedies;
- Warranty will not be valid unless Customer (i) notifies BOXX within 5 days of noticing any issues with Equipment that may be covered by Warranty; and (ii) maintains Equipment as described in Section 3(d). Warranty will not be valid if Equipment was subject to Damage. Unless visually obvious and noted by Customer in writing and provided to BOXX's agent or truck driver at the time of Delivery, BOXX does not warrant that Equipment is at that time or will be during the Term, free from mold, bacteria, fungus or other biological contaminants ("**Biological Contaminants**").
- Warranty is limited to supply of parts and rates for non-union labor to remedy defective components, and all other expenses associated with Warranty work, including freight, travel expense, room and board and

overhead must be paid by Customer. BOXX is not responsible for any actions, injuries, claims, liabilities, losses, damages, demands, penalties, fines, expenses (including legal expenses), costs, obligations and causes of action of any kind and nature whatsoever ("Claims") arising from defects except as set out in this Section 5(b)(iii).

- (iv) In order for Warranty to apply, Module(s) must be connected to an electric power line. In the event the Module(s) are connected to any alternative power source, this Warranty is void.

6. INSURANCE:

(a) Coverage:

- (i) Regardless of whether Customer has property coverage on the Structure as set out in Section 6(a)(ii), or participates in to the Structure Protection Plan in Section 6(a)(iii), Customer must at all times during the Term have commercial general liability insurance with coverage of not less than \$2,000,000 per occurrence. Such insurance policy must be primary and non-contributory; and name BOXX as an additional insured.
- (ii) Subject to Customer's participation in the Structure Protection Plan set out in Section 5(a)(iii), Customer must at all times during the Term have property insurance in place that covers the Structure at the full replacement value, against loss or damage from all perils, regardless of the cause, including negligence. Such policy must name BOXX as loss payee and must not contain penalty clauses or co-insurance, but if it does, specifically state that they will not be prejudicial to full reimbursement to BOXX. If the insurance proceeds are less than the full replacement value, Customer must pay the difference to BOXX.
- (iii) If the Customer elects to participate in the Structure Protection Plan, or if Customer fails to provide BOXX with evidence of property insurance as set out in Section 6(a)(ii) prior to delivery, BOXX will charge the Customer the monthly Structure Protection Plan Fee set out on the Cover Page as a substitute for the property insurance required under Section 6(a)(ii). The Structure Protection Plan will cover the Structure from significant damage or a complete loss resulting from an insurable event while the Structure is in the care, custody and control of the Customer. Customer is responsible for any deductibles payable under the Structure Protection Plan and remains liable for any damage to the Structure (and the Equipment) that may occur and is not covered by the Structure Protection Plan. Additional details may be found in the attached letter describing the Structure Protection Plan, which is incorporated into and forms a part of these Terms and Conditions.
- (b) **Other Insurance Requirements:** Customer must ensure that: each insurance policy contains a waiver of subrogation in favor of BOXX, the insurer has a rating of no less than A- by the A.M. Best Rating Guide, and the insurer agrees to give BOXX at least 30 days' prior written notice of cancellation of or changes to the insurance policy. Customer must provide BOXX with applicable certificate(s) of insurance prior to Delivery. Customer is responsible for payment of any insurance policy premiums and deductibles.
- ## **7. SERVICES:**
- (a) **Site Access:** Customer must provide BOXX with reliable and accurate information regarding transportation, Site conditions and access at least 10 business days prior to the date Equipment is to be transported to Site. BOXX will be entitled to enter the Site during normal business hours to inspect the Equipment. Barring an emergency, BOXX shall give Customer forty-eight (48) hours advance notice and shall not enter the Equipment without the presence of an employee or agent of Customer.
- (b) **Transportation Damage:** BOXX is not responsible for any loss or damage to Equipment during transportation, unless such loss or damage is noted in writing and provided to BOXX's agent or truck driver at the time of Delivery.
- (c) **Site:** Customer must ensure the Site is clear, level, able to bear the weight of the Equipment, and there must be a clear, flat working area that is 60 feet wider than the Module on each side unless otherwise agreed to by BOXX. Failure to meet the above requirements will void any Warranty or maintenance obligations BOXX may have, Equipment may not be installed or removed, there may be additional charges and Customer will be responsible for any delays.
- (d) **Extra Services:** BOXX may, at its discretion, perform any obligation of Customer, which Customer has failed to perform, perform additional services at the request of Customer, or as required to provide the requested Equipment and Services if information provided by Customer is incomplete or inaccurate (collectively "Extra Services"). At BOXX's option, the charges for the Extra Services will be calculated by BOXX in its sole discretion based on (i) a lump sum fee, or (ii) its time and materials cost, plus an applicable percentage mutually agreed upon by the parties.
- (e) **Delays:** If Equipment off/on-loading or performance of Services is delayed due to transportation delays, Site access conditions, Customer not fulfilling its obligations under this Contract or any delay caused by Customer, Customer will pay Rent and be invoiced for charges resulting from the delay at BOXX's cost plus 15%.

8. INDEMNITY AND LIMITATION ON DAMAGES:

- (a) **Indemnity:** Except to the extent caused solely by BOXX's negligence or willful misconduct in performing Services or BOXX's breach of this Contract, Customer will be liable for and will indemnify the BOXX Parties, against any Claims suffered by BOXX Parties which: (i) are caused by Customer's negligence, willful misconduct or breach of this Contract; (ii) relate to or arise during Customer's care, custody and control of Equipment; or (iii) relate to or arise from Biological Contaminants.
- (b) Customer, for itself, its successors, assigns and legal representatives, does hereby, now and for the future, agree to indemnify, defend, save and hold harmless the BOXX Parties, from and against any and all liability, damages and costs of any kind, nature or extent, including attorney's fees from all manner of action, actions, cause or causes of action, claims, proceedings, suits, debts, sums of money, claims, accounts, bonds, bills, specialties, controversies, judgments, assessments, penalties, for or on account of personal injuries, death or property damage, and all demands whatsoever, at law or in equity, arising directly or indirectly out of, or in connection with, Customer's or any of the BOXX Parties, and including all third-parties' use, occupancy or presence in, on or about the Equipment leased hereunder.
- (c) In the event Customer shall receive notice of any claim, suit or action for personal injury, death or property damage, Customer shall provide prompt written notification thereof to BOXX. In the event of commencement of any suit, action or proceeding, Customer shall immediately assume the defense of BOXX at its sole cost and expense and shall wholly indemnify the BOXX Parties as provided herein.
- (d) **Limitation on Liability:** Except for third party indemnification Claims or the Termination Fee, no party will be liable to the other party or obligated to indemnify the other party for exemplary, special, incidental, indirect, consequential or punitive damages or damages relating to loss of goodwill, use, revenue, profit or opportunity. BOXX Parties' maximum liability to Customer for any Claim in relation to this Contract may not exceed an amount equal to the total Rent during the Minimum Commitment.
- 9. FORCE MAJEURE:** BOXX will not be in default of the performance of any of its obligations under this Contract if it is prevented from doing so due to an event beyond its reasonable control, including but not limited to acts of God, acts of war, terrorism, material shortages, manufacturer delays, strikes, lockouts, civil disturbances, explosions, fires, transportation disruptions and weather conditions, disease, and pandemic, but only to the extent and for the time period that performance of such obligation is so prevented.
- ## **10. TERMINATION:**
- (a) **Termination for Cause – BOXX:** BOXX may immediately terminate this Contract upon notice to Customer if Customer: breaches a material term of this Contract, including failing to make payments when due or is in breach of any other agreement with BOXX, and fails to remedy the breach within 10 days of notice from BOXX. If BOXX terminates this Contract, Customer must pay BOXX an amount equal to: (A) the Rent that Customer is obligated to pay BOXX from the date of termination until the end of the Minimum Commitment, plus (B) the charge for the removal and transportation of Equipment back to BOXX (collectively, the "Termination Fee"), which fee is a genuine estimate of the damages BOXX would have suffered as a result of Customer's default and is not a penalty. Customer must also pay any costs incurred by BOXX under Section 4. Within 3 days of BOXX's termination of this Contract, Customer must make arrangements and cooperate with BOXX for the return of Equipment, failing which BOXX may enter Site and retake possession of Equipment without further notice. Notwithstanding such repossession, Customer will be liable for and indemnify the BOXX Parties against all costs incurred by the BOXX Parties relating to the repossession of Equipment and collection of amounts owing. BOXX will not be responsible for any damage arising from the repossession of Equipment, unless arising from BOXX's gross negligence, or for any personal property in or attached to the Equipment.
- (b) **Termination for Cause – Customer:** Customer may immediately terminate this Contract upon notice to BOXX if: BOXX breaches any material provision of this Contract, and fails to remedy the breach within 10 days of notice from Customer.
- 11. CHANGE ORDERS:** The Parties may, from time to time, agree to revise or modify the Cover Page by completing and executing a change order in the form provided by BOXX. Once each Party has executed the change order it will amend the Cover Page as of the effective date of the change order. Except as amended in the change order, this Contract will remain valid and unchanged.
- 12. GENERAL:** Notwithstanding anything to the contrary in this Contract, in the event that any amount is due to BOXX or any of its affiliates by the Customer or any of the Customer's affiliates, BOXX shall have the right of set-off against the Customer for that amount, whether such amount arises pursuant to this Contract, any other contracts between the Customer and/or the Customer's affiliates and BOXX, BOXX's affiliates or otherwise. Every notice to be given under this Contract must be in writing and sent by certified mail, return receipt requested, or by email, to the other party's

Address for Notices set out in Cover Page. A party may change its Address for Notices by providing notice. This Contract will be governed and construed under and in accordance with the laws of Pennsylvania without regard to conflict of law principles. All disputes arising in connection with this Contract, including any question regarding its existence or validity, shall be resolved by a State or Federal Court of BOXX's choosing. During the Term, each party must comply with all laws that apply to such party's performance, or are necessary for the other party's performance under this Contract. This Contract constitutes the entire agreement between the parties pertaining to the rental of Equipment and provision of Services. No modification or waiver of this Contract in whole or in part is binding unless it is in writing and duly executed by each party. No waiver of any provision in this Contract will constitute a waiver of any other provision, whether similar or not, or constitute a continuing waiver unless otherwise expressly provided. All Section headings contained herein are for the convenience of reference only and are not intended to define or limit the scope of any provision of this Contract. BOXX may assign this Contract in whole or in

part upon notice to Customer. Customer must not assign this Contract. If Customer sends BOXX a purchase order in respect of the Services or rental of Equipment, then that purchase order will be used to assist Customer in its internal accounting only and any terms or conditions contained in such purchase order will have no effect whatsoever on this Contract. Where a conflict exists between the Terms and Conditions and Cover Page, the provisions of the Terms and Conditions will take precedence. If any provision of this Contract is determined to be invalid, illegal or unenforceable in whole or in part, such invalidity, illegality or unenforceability will attach only to such provision and all other provisions in this Contract will continue in full force and effect. Sections 1, 2, 3, 4, 8, 8, 10(a), and 11 will survive the termination of this Contract and continue in full force and effect for the benefit of, and will be binding upon, the parties. This Contract may be executed by the parties using electronic copies in separate counterparts each of which when so executed and delivered will constitute one and the same document.

To Whom It May Concern:

This letter is written as a summary of insurance providing some details in what our Structure Protection Plan (the "Plan") includes in the way of coverage. It is not meant to take the place of an insurance certificate or policy nor is it an inclusive document detailing our entire coverage, exclusions, limits or other insurance details. **It is meant as a summary description** only, to the basic coverages you receive when you take advantage of our Plan. What the purchaser of our Plan receives is as follows:

Rented Asset Coverage

Provides coverage for significant damage to, or complete loss of our modular structures resulting from an insurable event while the asset(s) are under the care, custody and control of the Customer.

- Policy limit for each rental unit \$250,000 (Note 1)
- Policy limit per occurrence \$1,000,000 (Note 2)
- Deductible 15% of the insured value

Customer is responsible for payment of the deductible in the case of any claim for damage or loss.

IMPORTANT - Customer of this Plan continues to be responsible for the procurement and evidence of any required insurance relating to Commercial General Liability, Non-Owned Automobile Coverage or any other forms of coverage other than the above-mentioned Rented Asset Coverage. Customer is also responsible for contents of the rented modular structure(s) and any equipment inside the rented modular structure(s).

This notice is issued as a matter of information only and confers no rights to the Customer and imposes no liability on the owner.

Note 1 – For purposes of rentals of Complexes, each unit separately identified in the rental contract will be considered an individual rental unit.

Note 2 – While each unit is subject to a maximum coverage of \$250,000, a complex rental will be subject to a maximum coverage of \$1,000,000 for the total complex.

EXHIBIT A

CUSTOMER MAINTENANCE RESPONSIBILITY

As a condition precedent to BOXX granting a limited warranty of the Equipment, certain routine maintenance of the Equipment is required to be performed by the Customer. Such "Routine Maintenance" is at the sole expense of the Customer and includes, but is not limited to, regular janitorial services as needed and the following duties:

1. Change filters on HVAC units every two (2) months, or more frequently if the Equipment is located in a particularly dirty environment. Maintain a log of when the filter changes occur. Clean HVAC coils and inspect units quarterly. Generators are not to be used, as this can void the warranty on the HVAC units.
2. Ensure all return air registers are open and air passage is not blocked.
3. Clean air ducts every two years or more frequently if located in a dusty environment. Maintain a log of when ducts are cleaned.
4. Report leaks of all types, plumbing or rainwater, immediately to your local branch of BOXX as indicated on the Cover Page.
If a leak occurs,
 - a. Remove water spillage immediately. Turn off all power if any affected areas contain electrical wiring or lights.
 - b. Immediately dry any wet carpet or tile and other wet surfaces by appropriate methods.
 - c. Depending on the severity of the leak, dehumidifiers may be required to ensure dryness and prevent the growth of mold.
5. Under OSHA guidelines inspect roof(s) periodically and implement the following procedures:
 - a. Clean roof of all debris, especially sharp items such as nails, screws, stones, and tree branches.
 - b. Clean debris from, and unclog as necessary, all scuppers, gutters and downspouts.
 - c. Inspect roofing for visible tears or cracks or loose roofing material.
 - d. Inspect roof penetration flashings and roof termination caulking for cracks.
 - e. Remove snow if any to prevent leaks.
 - f. If any tears, leaks or cracks are found, contact BOXX immediately for instructions and to arrange for repairs.
6. Maintain adequate storm water drainage away from the Equipment and ensure that no water is allowed to pond beneath buildings.
7. Maintain floor coverings in good, safe, serviceable condition:
 - a. Dry or damp mop vinyl covered floors. Do not wet mop vinyl covered surfaces.
 - b. Strip, seal and wax vinyl tile floor covering at least once a year.
 - c. Trim carpet snags/ravels to prevent further carpet damage or creating a tripping hazard
 - d. Do not use tape on carpet to seal rips or frayed/loose seams.
8. Perform additional routine maintenance as required by use or environment:
 - a. Do not staple, tack, tape items to walls or punch holes into walls.
 - b. Replace batteries in smoke detectors/emergency exit lights at least once a year or more frequently if required to maintain them in safe condition. Test all smoke detectors per local code or manufacturer's requirements.
 - c. Replace fluorescent lamps, incandescent bulbs or other lighting as needed.
 - d. Check rain diverters caulking over doors and windows. Re-caulk as needed. If rain diverters do not keep blowing rain from penetrating doors, canopies over doors may be required.
 - e. Caulk siding materials and window frames as needed to prevent water penetration.
 - f. Maintain air conditioning temperature between 70-76 degrees in hot weather during evenings, weekends and holidays to maintain reasonable temperature and humidity in the Equipment and lubricate the equipment. Use programmable T-stats with lock boxes when possible.
 - g. Ensure skirting vents are not blocked at all times.
 - h. Do not remove inspection/data labels from walls, doors, windows and electrical panels.
 - i. Ensure and maintain all necessary pest and animal controls.

FIRE HAZARD WARNING

- i. Maintain a 3' clearance around electrical panels
- ii. Do not overload the electrical outlets
- iii. Do not place objects on top or in front of electric heaters
- iv. Do not block any vent
- v. Clothing and flammable materials should not be stored in closets with electrical panels
- vi. Furnace and water tank closets should not be used for storage
