

2025 Tomball Health Coalition/Tri County Health Alliance Grant Guidelines

Background and focus: Tomball Health Coalition is a 501(c)(3) created in January of 2013 and dedicated to helping the health needs in Tomball, Magnolia, Waller and surrounding communities.

Board Meetings and Proposal Review: The Board of Directors meets monthly. The Coalition accepts applications on an on-going basis. Proposals that staff are unable to review for the next scheduled Board meeting are held over for the following months meeting.

The Coalition will notify the applicant by letter or email that the proposal has been received. If any additional information is required, it will be requested at that time. Applicants are notified by letter regarding any action taken by the Board of Directors with respect to their request for funding.

Eligibility:

- Organizations applying for funds must be tax exempt under sections 501 (c)(3) or 170 (c) of the Internal Revenue Code and be classified as a public charity under section 509 (a) of the Code
- Organizations located in and around Tomball, Magnolia and Waller
- Organizations and agencies may request funds only once during a calendar year (exceptional circumstances are taken into consideration)
- Organizations that have been previously funded must submit a final evaluation report before requesting additional funds
- Except in special circumstances, organizations receiving multi-year grants may not request additional funds until the grant has been paid in full and a final evaluation report has been submitted.

Tomball Health Coalition supports:

- Health and wellness initiatives in the greater Tomball, Magnolia and Waller area.

Restrictions:

- Grants for religious purposes
- Grants for hiring staff.
- Grants for computers or software
- Grants for food or travel
- Pass-through grants
- Underwriting or contributions to luncheons, galas and social fundraisers
- Grants for major medical research projects
- Requests for individual scholarships
- Major arts organizations
- Grants supporting candidates for political office, political parties or PACs.
- International organizations
- Grants to local, national or international organizations' annual giving or holiday campaigns
- Grants to 509 (a) (3) Type III supporting organizations.

F. Brief Description of Request:

Funding to purchased AED's for patrol vehicles and fire trucks in Waller County, and stop the bleed kits for school district classrooms. \$20,000 for AED;s and \$5,000 for Stop the bleed kits/tourniquets for school classrooms for Hempstead ISD, Waller ISD and Royal ISD.

I received a request from the Waller-Harris ESD#200 Fire Department for help with funding to put AED's on Fire trucks and booster trucks. This \$30,000-dollar request will help purchase AED's for multiple fire trucks and first responder units. Just a few weeks ago we responded to an electrocution where CPR and AED was used to revive a 22-year-old man in Waller County. To this date, he is still alive and recovering. I understand the importance to have these AED units on every first responder vehicle in Waller County.

Since last years request additional housing neighborhoods and commercial businesses have opened or are being built in Waller County.

Thank you for your consideration and past support you have given to Waller County.

II. Waller County was founded in 1873, with a population of over 59,781.

III. Cities within Waller County are Hempstead, Prairie View, Brookshire, Pattison, and Pine Island.

IV. School districts in Waller County are Waller ISD, Royal ISD and Hempstead ISD. Waller ISD district covers two counties, Waller and Harris.

VI. Over the last 20 years, significant population growth has occurred. The "0-24" age group was the largest and fastest growing age group in Waller County, although this may be skewed by the college population of Prairie View A&M University.

VIII. The 1995 County household income was nearly equivalent to 1990 levels, although 25. 1 % lower than in 1979.

X. Physical features consist of rolling prairies that drain to the Brazos and San Jacinto Rivers, with alluvial soils, and the area is one-fifth forested. Much of the vegetation consists of

cultivated prairie grassland and pastureland. Recreation consists of fishing, hunting, historic sites, historical museums, Chamber of commerce Festivals, and the Waller County Fair.
